On page 1, in lines 3 and 4, strike "age and gender-related identity or expression" and substitute "gender identity"; strike beginning with "requiring" in line 6 down through "information;" in line 7; in lines 7 and 8, strike "Board of Regents of the University System of Maryland to develop and offer a curriculum for" and substitute "<u>University System of Maryland to manage the development of</u>"; strike beginning with "authorizing" in line 9 down through "material" in line 13 and substitute "<u>defining a certain term</u>"; strike in their entirety lines 14 through 18, inclusive; and in line 21, strike "10–301(c)" and substitute "<u>10–301</u>".

On page 2, strike in their entirety lines 2 through 6, inclusive.

#### AMENDMENT NO. 2

On page 2, after line 11, insert:

# "(B) "GENDER IDENTITY" HAS THE MEANING STATED IN § 20–101 OF THE STATE GOVERNMENT ARTICLE.

- [(b)] (C) <u>"Homeless" means:</u>
  - (1) lacking a fixed, regular, and adequate nighttime residence; or
  - (2) having a primary nighttime residence that is:

(i) <u>a supervised publicly or privately operated shelter designed</u> to provide temporary living accommodations; or

(ii) <u>a public or private place not designed for or ordinarily used as</u> <u>a regular sleeping accommodation for human beings.</u>";

On page 3, in line 4, strike "GENDER-RELATED IDENTITY OR EXPRESSION," and substitute "<u>GENDER IDENTITY</u>,"; in line 5, strike the brackets; in the same line, strike "OR AGE,"; strike beginning with "GENDER-RELATED" in line 8 down through "EXPRESSION," in line 9 and substitute "<u>GENDER IDENTITY</u>,"; in line 9, strike the brackets; in the same line, strike ", OR AGE"; in line 21, strike "(1)"; strike beginning with "(2)" in line 24 down through "SUBSECTION." in line 29; in line 32, strike "(A)"; in the same line, strike "BOARD OF REGENTS" and substitute "<u>UNIVERSITY SYSTEM</u> <u>OF MARYLAND</u>"; in line 33, strike "DEVELOP A CURRICULUM FOR" and substitute "<u>MANAGE THE DEVELOPMENT OF</u>"; and in the same line, after "PROGRAM" insert "<u>THAT PROVIDES ANTIBIAS EDUCATION RELEVANT TO THE PROVISIONS OF TITLE</u> **10, SUBTITLE 3 OF THE CRIMINAL LAW ARTICLE**".

On page 4, strike in their entirety lines 1 through 20, inclusive.
