On pages 7 and 8, strike in their entirety the lines beginning with line 27 on page 7 through line 20 on page 8, inclusive.

AMENDMENT NO. 2

On page 40 in line 8, and on page 45 in line 2, in each instance, strike "§ 9-1605.2(I)(11)(I)" and substitute "§ 2-1212(D)".

On page 41, after line 28, insert:

"(D) (1) IN FISCAL YEARS 2022 THROUGH 2030 THE GOVERNOR SHALL APPROPRIATE:

(I) \$10,000,000 PER FISCAL YEAR TO THE CHESAPEAKE BAY TRUST FOR THE URBAN TREES PROGRAM ESTABLISHED UNDER § 8–1911 OF THE NATURAL RESOURCES ARTICLE;

(II) \$2,500,000 PER FISCAL YEAR TO THE CHESAPEAKE AND ATLANTIC COASTAL BAYS 2010 TRUST FUND IN THE DEPARTMENT OF NATURAL RESOURCES, TO BE USED, SUBJECT TO THE REQUIREMENTS OF PARAGRAPH (2) OF THIS SUBSECTION, FOR TREE PLANTING ON PUBLIC AND PRIVATE LAND; AND

(III) \$2,500,000 PER FISCAL YEAR TO THE MARYLAND

(III) MAY NOT BE USED TO PLANT TREES INTENDED FOR TIMBER HARVEST; AND

(IV) MAY BE USED ONLY FOR TREE PLANTINGS ON PRIVATE LAND IF THE LANDOWNER ENTERS INTO A BINDING LEGAL AGREEMENT TO MAINTAIN THE PLANTED AREA IN TREE COVER FOR AT LEAST 15 YEARS.
