On page 8, in lines 9, 18, 25, 30, and 35, strike "5.", "6.", "7.", "8.", and "9.", respectively, and substitute "<u>6.</u>", "<u>7.</u>", "<u>8.</u>", "<u>9.</u>", and "<u>10.</u>", respectively; after line 8, insert:

"<u>SECTION 5. AND BE IT FURTHER ENACTED</u>, That nothing in this Act shall be construed to reduce the annual allocation of funds for rural broadband infrastructure expansion under the Office of Statewide Broadband.";

in line 27, strike "Digital Inclusion" and substitute "<u>Statewide Broadband</u>"; in lines 32 and 33, strike "Digital Inclusion" and substitute "<u>Statewide Broadband</u>"; and strike beginning with "shall" in line 35 down through "2021" in line 36 and substitute "<u>is an</u> <u>emergency measure</u>, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three-fifths of all the <u>members elected to each of the two Houses of the General Assembly</u>, and shall take <u>effect from the date it is enacted</u>. It shall remain effective through June 30, 2030, and,

at the end of June 30, 2030, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect".
