On page 17 of the House Judiciary Committee Amendments, in line 12 of Amendment No. 2, after "<u>NOTICE</u>" insert "<u>AND A COPY</u>"; in line 13, after "<u>SUBSECTION</u>" insert "<u>, ALONG WITH INSTRUCTIONS TO OBTAIN INDEPENDENT</u> <u>COUNSEL</u>,"; and in the same line, after "<u>SERVED</u>" insert "<u>, BY THE ATTORNEY</u> <u>GENERAL OR THE STATE'S ATTORNEY PROSECUTING THE CASE BY DIRECT</u> <u>PERSONAL SERVICE</u>,".
