Criminal Law - Hate Crimes - Protected Groups and Penalties

- 3 FOR the purpose of altering a certain definition in the context of hate crimes; including age and gender-related identity or expression gender identity in the list of 4 5 characteristics on the basis of which a person may not commit certain acts; 6 authorizing a court to require an offender convicted of hate crimes to complete a 7 certain program; requiring a court to provide certain offenders with certain 8 information: requiring the Board of Regents of the University System of Maryland 9 to develop and offer a curriculum for University System of Maryland to manage the 10 development of a certain program; authorizing the Board to charge a reasonable fee to participate in the program, subject to a certain exception; requiring the Board to 11 develop certain material on the program and share that material with the Maryland 12 Commission on Civil Rights; requiring the Commission to ensure that certain 13 offenders have access to the material defining a certain term; and generally relating 14 to hate crimes. 15

Motivated either in whole or in substantial part by another person's or group's race, color, religious beliefs, sexual orientation, gender, GENDER IDENTITY OR EXPRESSION, GENDER IDENTITY, disability, for national origin, OR AGE, or because another person or group is homeless, a person may not:

- 5 (1) (i) commit a crime or attempt or threaten to commit a crime against 6 that person or group;
- 7 (ii) deface, damage, or destroy, or attempt or threaten to deface, 8 damage, or destroy the real or personal property of that person or group; or
- 9 (iii) burn or attempt or threaten to burn an object on the real or 10 personal property of that person or group; or
- 11 (2) commit a violation of item (1) of this section that:
- 12 (i) except as provided in item (ii) of this item, involves a separate 13 crime that is a felony; or
- 14 (ii) results in the death of a victim.

A person may not deface, damage, or destroy, attempt or threaten to deface, damage, or destroy, burn or attempt or threaten to burn an object on, or damage the real or personal property connected to a building that is publicly or privately owned, leased, or used, including a cemetery, library, meeting hall, recreation center, or school:

- 20 (1) because a person or group of a particular race, color, religious belief, 21 sexual orientation, gender, GENDER-RELATED IDENTITY OR EXPRESSION, GENDER 22 IDENTITY, disability, for national origin, OR AGE, or because a person or group that is 23 homeless, has contacts or is associated with the building; or
- 24 (2) if there is evidence that exhibits animosity against a person or group, 25 because of the race, color, religious beliefs, sexual orientation, gender, GENDER RELATED 26 IDENTITY OR EXPRESSION, GENDER IDENTITY, disability, for national origin, OR AGE 27 of that person or group or because that person or group is homeless.

- 29 (a) Except as provided in subsection (b) of this section, a person who violates this 30 subtitle is guilty of a misdemeanor and on conviction is subject to imprisonment not 31 exceeding 3 years or a fine not exceeding \$5,000 or both.

- 1 (b) (1) A person who violates § 10–304(2)(i) of this subtitle is guilty of a felony 2 and on conviction is subject to imprisonment not exceeding 10 years or a fine not exceeding 3 \$10,000 or both.
- 4 (2) A person who violates § 10–304(2)(ii) of this subtitle is guilty of a felony 5 and on conviction is subject to imprisonment not exceeding 20 years or a fine not exceeding 6 \$20,000 or both.
- 7 (C) (1) IN ADDITION TO ANY OTHER PENALTIES IMPOSED BY THIS 8 SECTION, THE COURT MAY REQUIRE A PERSON WHO VIOLATES THIS SUBTITLE TO 9 COMPLETE AN ANTIBIAS EDUCATION PROGRAM.
