## A BILL ENTITLED

1 AN ACT concerning

2 **Law Enforcement – Department of State Police – Body-Worn Cameras**

3 FOR the purpose of requiring, on or before a certain date, the Department of State Police  
4 to adopt policies and procedures for the use of body-worn cameras consistent with  
5 certain policies developed by the Maryland Police Training and Standards  
6 Commission; requiring, on or before a certain date, the Department to issue  
7 body-worn cameras for police employees of the Department to use while on duty,  
8 subject to a certain exception; and generally relating to body-worn cameras and the  
9 Department of State Police.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
26 That the Laws of Maryland read as follows:

## Article – Public Safety

3 (i) “Police employee” means an employee of the Department to whom the  
4 Secretary assigns the powers contained in § 2–412 of this title.

5 2–407.

6 (a) (1) The Department shall provide uniforms and equipment necessary for  
7 the performance of the duties of employees in accordance with the State budget.

8 (2) Uniforms and equipment shall be purchased by the Department in  
9 accordance with Division II of the State Finance and Procurement Article and remain the  
10 property of the State.

11 (b) (1) Subject to paragraph (2) of this subsection, the Secretary may grant  
12 permission to off-duty police employees to use police vehicles during off-duty hours if, in  
13 the opinion of the Secretary, the vehicles will not be needed by on-duty police employees.

14 (2) Only the police employees to whom permission has been granted to use  
15 the police vehicles may operate the police vehicles.

16 (c) (1) **ON OR BEFORE JANUARY 1, 2022, THE DEPARTMENT SHALL**  
17 **ISSUE BODY-WORN CAMERAS FOR USE BY POLICE EMPLOYEES WHILE ON DUTY.**

18 (2) **THIS SUBSECTION DOES NOT APPLY TO POLICE EMPLOYEES**  
19 **ASSIGNED TO WORK IN THE MARYLAND STATE HOUSE.**

21 On or before January 1, 2016, the Maryland Police Training and Standards  
22 Commission shall develop and publish online a policy for the issuance and use of a  
23 body-worn camera by a law enforcement officer that addresses:

24 (1) the testing of body-worn cameras to ensure adequate functioning;

25 (2) the procedure for the law enforcement officer to follow if the camera  
26 fails to properly operate at the beginning of or during the law enforcement officer’s shift;

27 (3) when recording is mandatory;

28 (4) when recording is prohibited;

29 (5) when recording is discretionary;

- 1 (6) when recording may require consent of a subject being recorded;
- 2 (7) when a recording may be ended;
- 3 (8) providing notice of recording;
- 4 (9) access to and confidentiality of recordings;
- 5 (10) the secure storage of data from a body-worn camera;
- 6 (11) review and use of recordings;
- 7 (12) retention of recordings;
- 8 (13) dissemination and release of recordings;
- 9 (14) consequences for violations of the agency's body-worn camera policy;
- 10 (15) notification requirements when another individual becomes a party to
- 11 the communication following the initial notification;
- 12 (16) specific protections for individuals when there is an expectation of
- 13 privacy in private or public places; and
- 14 (17) any additional issues determined to be relevant in the implementation
- 15 and use of body-worn cameras by law enforcement officers.

17 **ON OR BEFORE JANUARY 1, 2022, THE DEPARTMENT OF STATE POLICE**  
18 **SHALL ADOPT POLICIES AND PROCEDURES FOR THE USE OF BODY-WORN CAMERAS**  
19 **CONSISTENT WITH THE POLICIES DEVELOPED BY THE MARYLAND POLICE**  
20 **TRAINING AND STANDARDS COMMISSION UNDER § 3-511 OF THIS SUBTITLE.**

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
22 October 1, 2021.
