A BILL ENTITLED

1 AN ACT concerning

2 **Health Occupations – Podiatric Physicians**

3 FOR the purpose of altering the term “podiatrist” to be “podiatric physician”; requiring the
4 publisher of the Annotated Code of Maryland, in consultation with and subject to the
5 approval of the Department of Legislative Services, to correct any cross-references
6 or terminology rendered incorrect by this Act and to describe any corrections made
7 in an editor’s note following the section affected; and generally relating to podiatric
8 physicians.

2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
3 That the Laws of Maryland read as follows:

29 program, an assisted living program, a freestanding ambulatory care facility as defined in

1 § 19–3B–01 of the Health – General Article, a physician, an osteopath, an optometrist, a
2 chiropractor, a registered or licensed practical nurse, a dentist, a [podiatrist] **PODIATRIC**
3 **PHYSICIAN**, a psychologist, a licensed certified social worker–clinical, and a physical
4 therapist, licensed or authorized to provide one or more health care services in Maryland.

7 (c) (3) The Secretary may contract with insurance companies or nonprofit
8 health service plans or with individuals, associations, partnerships, incorporated or
9 unincorporated groups of physicians, chiropractors, dentists, [podiatrists] **PODIATRIC**
10 **PHYSICIANS**, optometrists, pharmacists, hospitals, nursing homes, nurses, including
11 nurse anesthetists, nurse midwives and certified nurse practitioners, opticians, and other
12 health practitioners who are licensed or certified in this State and perform services on the
13 prescription or referral of a physician.

15 (b) (1) A hospital or related institution that provides services that licensed
16 [podiatrists] **PODIATRIC PHYSICIANS** are authorized to perform under Title 16 of the
17 Health Occupations Article, other than incidental care, shall include, in its bylaws, rules,
18 or regulations, provisions for use of facilities by and staff privileges for qualified
19 [podiatrists] **PODIATRIC PHYSICIANS**.

20 (2) The hospital or related institution may restrict use of facilities and staff
21 privileges by [podiatrists] **PODIATRIC PHYSICIANS** to those [podiatrists] **PODIATRIC**
22 **PHYSICIANS** who meet the qualifications that the hospital or related institution sets for
23 granting those privileges.

24 (3) The qualifications that the hospital or related institution sets for
25 granting privileges for services that licensed [podiatrists] **PODIATRIC PHYSICIANS** are
26 authorized to perform under Title 16 of the Health Occupations Article shall include
27 consideration of the training, education, and experience of the [podiatrist] **PODIATRIC**
28 **PHYSICIAN**.

30 (f) If a health maintenance organization authorizes, directs, refers, or otherwise
31 allows a member or subscriber to access a hospital emergency facility or other urgent care
32 facility for a medical condition that requires emergency surgery, the health maintenance
33 organization:

1 (1) Shall reimburse the physician, oral surgeon, periodontist, or
 2 [podiatrist] **PODIATRIC PHYSICIAN**, who performed the surgical procedure, for follow-up
 3 care that is:

4 (i) Medically necessary;

5 (ii) Directly related to the condition for which the surgical procedure
 6 was performed; and

7 (iii) Provided in consultation with the member's or subscriber's
 8 primary care physician; and

9 (2) May not impose on the member or subscriber any co-payment or other
 10 cost-sharing requirement for any follow-up care that exceeds what a member or subscriber
 11 is required to pay for services rendered by a physician, oral surgeon, periodontist, or
 12 [podiatrist] **PODIATRIC PHYSICIAN** who is a member of the provider panel of the health
 13 maintenance organization.

8 (a) In this title the following words have the meanings indicated.

9 (b) “Authorized prescriber” means any licensed dentist, licensed dental hygienist
10 with prescriptive authority under § 4–206.4 of this article, licensed physician, licensed
11 [podiatrist] **PODIATRIC PHYSICIAN**, licensed veterinarian, advanced practice nurse with
12 prescriptive authority under § 8–508 of this article, or other individual authorized by law
13 to prescribe prescription or nonprescription drugs or devices.

15 (a) (1) In this section the following terms have the meanings indicated.

16 (2) “In the public interest” means the dispensing of drugs or devices by a
17 licensed dentist, physician, or [podiatrist] **PODIATRIC PHYSICIAN** to a patient when a
18 pharmacy is not conveniently available to the patient.

19 (3) “Personally preparing and dispensing” means that the licensed dentist,
20 physician, or [podiatrist] **PODIATRIC PHYSICIAN**:

21 (i) Is physically present on the premises where the prescription is
22 filled; and

23 (ii) Performs a final check of the prescription before it is provided to
24 the patient.

25 (c) (2) This title does not prohibit:

26 (ii) A licensed dentist, physician, or [podiatrist] **PODIATRIC**
27 **PHYSICIAN** from personally preparing and dispensing the dentist’s, physician’s, or
28 [podiatrist’s] **PODIATRIC PHYSICIAN’S** prescriptions when:

29 1. The dentist, physician, or [podiatrist] **PODIATRIC**
30 **PHYSICIAN**:

1 A. Has applied to the board of licensure in this State which
2 licensed the dentist, physician, or [podiatrist] **PODIATRIC PHYSICIAN**;

3 B. Has demonstrated to the satisfaction of that board that the
4 dispensing of prescription drugs or devices by the dentist, physician, or [podiatrist]
5 **PODIATRIC PHYSICIAN** is in the public interest;

6 C. Has received a written permit from that board to dispense
7 prescription drugs or devices except that a written permit is not required in order to
8 dispense starter dosages or samples without charge; and

9 D. Posts a sign conspicuously positioned and readable
10 regarding the process for resolving incorrectly filled prescriptions or includes written
11 information regarding the process with each prescription dispensed;

12 2. The person for whom the drugs or devices are prescribed
13 is a patient of the prescribing dentist, physician, or [podiatrist] **PODIATRIC PHYSICIAN**;

14 3. The dentist, physician, or [podiatrist] **PODIATRIC**
15 **PHYSICIAN** does not have a substantial financial interest in a pharmacy; and

16 4. The dentist, physician, or [podiatrist] **PODIATRIC**
17 **PHYSICIAN**:

18 A. Complies with the dispensing and labeling requirements
19 of this title;

20 B. Records the dispensing of the prescription drug or device
21 on the patient's chart;

22 C. Allows the Office of Controlled Substances Administration
23 to enter and inspect the dentist's, physician's, or [podiatrist's] **PODIATRIC PHYSICIAN'S**
24 office at all reasonable hours and in accordance with § 12-102.1 of this subtitle;

25 D. On inspection by the Office of Controlled Substances
26 Administration, signs and dates an acknowledgment form provided by the Office of
27 Controlled Substances Administration relating to the requirements of this section;

28 E. Except for starter dosages or samples without charge,
29 provides the patient with a written prescription, maintains prescription files in accordance
30 with § 12-403(c)(13) of this title, and maintains a separate file for Schedule II prescriptions;

31 F. Does not direct patients to a single pharmacist or
32 pharmacy in accordance with § 12-403(c)(8) of this title;

33 G. Does not receive remuneration for referring patients to a

1 pharmacist or pharmacy;

2 H. Complies with the child resistant packaging requirements
3 regarding prescription drugs under Title 22, Subtitle 3 of the Health – General Article;

4 I. Complies with drug recalls;

5 J. Maintains biennial inventories and complies with any
6 other federal and State record-keeping requirements relating to controlled dangerous
7 substances;

8 K. Purchases prescription drugs from a pharmacy or
9 wholesale distributor who holds a permit issued by the Board of Pharmacy, as verified by
10 the Board of Pharmacy;

11 L. Annually reports to the respective board of licensure
12 whether the dentist, physician, or [podiatrist] **PODIATRIC PHYSICIAN** has personally
13 prepared and dispensed prescription drugs within the previous year; and

14 M. Completes ten continuing education credits over a 5-year
15 period relating to the preparing and dispensing of prescription drugs, offered by the
16 Accreditation Council for Pharmacy Education (ACPE) or as approved by the Secretary, in
17 consultation with each respective board of licensure, as a condition of permit renewal;

18 (d) This title does not prohibit:

19 (2) A licensed dentist, licensed physician, or licensed [podiatrist]
20 **PODIATRIC PHYSICIAN** from personally dispensing a drug or device sample to a patient of
21 the licensed dentist, licensed physician, or licensed [podiatrist] **PODIATRIC PHYSICIAN** if:

22 (i) The sample complies with the labeling requirements of § 12–505
23 of this title;

24 (ii) No charge is made for the sample; and

25 (iii) The authorized prescriber enters an appropriate record in the
26 patient's chart.

27 (e) (1) This title does not prohibit a dentist, physician, or [podiatrist]
28 **PODIATRIC PHYSICIAN** from administering a prescription drug or device in the course of
29 treating a patient.

30 (f) (1) This title does not prohibit a dentist, physician, or [podiatrist]
31 **PODIATRIC PHYSICIAN** from personally dispensing a starter dosage of a prescription drug
32 or device to a patient of the dentist, physician, or [podiatrist] **PODIATRIC PHYSICIAN**,
33 provided that:

1 (i) The starter dosage complies with the labeling requirements of §
2 12-505 of this title;

3 (ii) No charge is made for the starter dosage; and

4 (iii) The dentist, physician, or [podiatrist] **PODIATRIC PHYSICIAN**
5 enters an appropriate record on the patient's chart.

6 (g) This title does not prohibit a dentist, physician, or [podiatrist] **PODIATRIC**
7 **PHYSICIAN** from dispensing a prescription drug or device in the course of treating a
8 patient:

9 (1) At a medical facility or clinic that is operated on a nonprofit basis;

10 (2) At a health center that operates on a campus of an institution of higher
11 education; or

12 (3) At a public health facility, a medical facility under contract with a State
13 or local health department, or a facility funded with public funds.

14 (m) A dentist, physician, or [podiatrist] **PODIATRIC PHYSICIAN** who fails to
15 comply with the provisions of this section governing the dispensing of prescription drugs or
16 devices shall:

17 (1) Have the dispensing permit revoked; and

18 (2) Be subject to disciplinary actions by the appropriate licensing board.

20 (b) The Office of Controlled Substances Administration shall enter and inspect
21 the office of a dentist, physician, or [podiatrist] **PODIATRIC PHYSICIAN** who holds:

22 (1) An initial dispensing permit:

23 (i) Within 6 months after receiving the report required under §
24 12-102(l)(1) of this subtitle; and

25 (ii) At least one more time during the duration of the permit; and

26 (2) A renewed dispensing permit at least two times during the duration of
27 the permit.

29 (b) The Board of Dental Examiners, the Board of Physicians, and the Board of

1 Podiatric Medical Examiners shall charge a fee to a dentist, physician, or [podiatrist]
2 **PODIATRIC PHYSICIAN** who holds a dispensing permit in an amount that will produce
3 funds to approximate but not exceed the documented costs to the Office of Controlled
4 Substances Administration for inspections of dispensing permit holders.

6 (a) In this subtitle the following words have the meanings indicated.

7 (b) “Authorized prescriber” means a licensed physician, licensed [podiatrist]
8 **PODIATRIC PHYSICIAN**, or certified advanced practice nurse with prescriptive authority
9 under § 8-508 of this article.

11 (b) A license does not authorize a licensee to:

12 (3) Practice or claim to practice as a medical doctor or physician, an
13 osteopath, a dentist, a [podiatrist] **PODIATRIC PHYSICIAN**, an optometrist, a psychologist,
14 a nurse practitioner, a physician assistant, a chiropractor, a physical therapist, an
15 acupuncturist, or any other health care professional unless licensed under this article;

18 (a) In this title the following words have the meanings indicated.

19 (d) “Licensed [podiatrist] **PODIATRIC PHYSICIAN**” means, unless the context
20 requires otherwise, a [podiatrist] **PODIATRIC PHYSICIAN** who is licensed by the Board to
21 practice podiatry.

22 (e) [“Podiatrist”] **“PODIATRIC PHYSICIAN”** means an individual who practices
23 podiatry.

24 16-103.

25 (a) All osseous surgical procedures of the ankle, arthrodeses of 2 or more tarsal
26 bones, and complete tarsal osteotomies that are performed by a licensed [podiatrist]
27 **PODIATRIC PHYSICIAN** shall be performed in a licensed hospital or ambulatory surgical
28 center, subject to the provisions of § 19-351 of the Health – General Article.

29 (b) A licensed [podiatrist] **PODIATRIC PHYSICIAN** who performs an osseous
30 surgical procedure of the ankle, arthrodesis of 2 or more tarsal bones, or a complete tarsal
31 osteotomy in a licensed ambulatory surgical center must:

1 (1) Have current surgical privileges at a licensed hospital for the same
2 procedure; and

3 (2) Meet the requirements of the ambulatory surgical center.

4 (c) Nothing in this title shall prohibit a licensed hospital or ambulatory surgical
5 center from establishing qualifications or delineating privileges for the performance of
6 surgical procedures of the human foot or ankle, the anatomical structures that attach to
7 the human foot, or the soft tissue below the mid-calf by a licensed [podiatrist] **PODIATRIC**
8 **PHYSICIAN** in the hospital or ambulatory surgical center.

9 16–202.

10 (a) (2) Of the 7 Board members:

11 (i) 5 shall be licensed [podiatrists] **PODIATRIC PHYSICIANS**; and

12 (ii) 2 shall be consumer members.

13 (3) The Governor shall appoint the [podiatrist] **PODIATRIC PHYSICIAN**
14 members, with the advice of the Secretary, from a list of names submitted by the Maryland
15 Podiatric Medical Association. The number of names on the list shall be twice the number
16 of vacancies.

17 (c) Each [podiatrist] **PODIATRIC PHYSICIAN** member of the Board shall be:

18 (1) A licensed practicing [podiatrist] **PODIATRIC PHYSICIAN** of recognized
19 ability and integrity;

20 (2) A resident of this State who has practiced actively in this State for at
21 least 5 years immediately before appointment; and

22 (3) A licensed [podiatrist] **PODIATRIC PHYSICIAN** with peer review
23 experience.

24 (d) Each consumer member of the Board:

25 (2) May not be or ever have been a [podiatrist] **PODIATRIC PHYSICIAN** or
26 in training to become a [podiatrist] **PODIATRIC PHYSICIAN**;

27 (3) May not have a household member who is a [podiatrist] **PODIATRIC**
28 **PHYSICIAN** or in training to become a [podiatrist] **PODIATRIC PHYSICIAN**;

29 16–205.

30 (a) In addition to the powers set forth elsewhere in this title, the Board may:

1 (2) After consulting with the State Board of Pharmacy, adopt rules and
2 regulations regarding the dispensing of prescription drugs by a licensed [podiatrist]
3 **PODIATRIC PHYSICIAN**; and

4 (b) In addition to the duties set forth elsewhere in this title, the Board shall:
