## A BILL ENTITLED

## Courts - Prohibited Indemnity and Defense Liability Agreements

3 FOR the purpose of prohibiting a provision in a contract or an agreement with a design 4 professional for professional services that requires the design professional to 5 indemnify or hold harmless certain parties unless the design professional is at fault 6 for causing the loss, damage, or expense indemnified; prohibiting a provision in a 7 contract or an agreement with a design professional for professional services that 8 requires the design professional to defend certain parties against liability or certain 9 claims; providing that certain provisions of law may not be interpreted to prohibit a 10 certain otherwise enforceable indemnity or hold harmless agreement from including 11 recovery of certain attorney's fees and defense costs in cases where the fault of the 12 promisor or its derivative parties is determined to be the proximate cause of the 13 defense costs to be indemnified; defining certain terms; and generally relating to 14 indemnity and defense liability agreements.

  LICENSURE IS REQUIRED UNDER, TITLE 3, TITLE 8, TITLE 9, TITLE 14, OR TITLE 15
  OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE.

- (2) A PROVISION, covenant, promise, agreement, or understanding in, or in connection with or collateral to, a contract or agreement relating to architectural, engineering, inspecting, or surveying services, or the construction, alteration, repair, or maintenance of a building, structure, HIGHWAY, ROAD, appurtenance or appliance, including moving, demolition, and excavating connected with those services or that work, purporting to indemnify the promisee against liability for damages arising out of bodily injury to any person or damage to property caused by or resulting from the sole negligence of the promisee or indemnitee, or the agents or employees of the promisee or indemnitee, is against public policy and is void and unenforceable.
