## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Business Regulation – Home Improvement Contracts – Deposits**

3 FOR the purpose of ~~increasing~~ specifying the maximum portion of a home improvement  
4 contract price that a person may receive ~~as a deposit before or at the time of execution~~  
5 ~~of a home improvement contract~~ when work commences on a certain project;  
6 prohibiting a person from receiving the remaining amount of a home improvement  
7 contract price until the completion of the home improvement specified in the  
8 contract, except under certain circumstances; and generally relating to home  
9 improvement contracts.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That the Laws of Maryland read as follows:

17 **Article – Business Regulation**

18 8–617.

19 (a) A person may not demand or receive any payment for a home improvement

3 **(1)** a deposit of more than ~~one-third~~ ~~ONE-HALF~~ of the home  
4 improvement contract price before or at the time of execution of the home improvement  
5 contract;

6 **(2)** PAYMENT OF MORE THAN ONE-HALF OF THE TOTAL AMOUNT OF  
7 THE HOME IMPROVEMENT CONTRACT PRICE BEFORE WORK COMMENCES ON THE  
8 PROJECT; OR

9 **(3)** THE REMAINING AMOUNT OF THE HOME IMPROVEMENT  
10 CONTRACT PRICE:

11 **(I)** UNTIL THE HOME IMPROVEMENT SPECIFIED IN THE  
12 CONTRACT IS COMPLETE; OR

13 **(II)** FOR A CONTRACT VALUED AT \$10,000 OR MORE:

14 **1.** UNTIL THE HOME IMPROVEMENT SPECIFIED IN THE  
15 CONTRACT IS COMPLETE; OR

16 **2.** IF APPLICABLE, UNLESS PAYMENT IS RECEIVED IN  
17 THE MANNER SPECIFIED UNDER A DRAW SCHEDULE THAT THE PARTIES MUTUALLY  
18 AGREED TO AT THE TIME THE CONTRACT WAS SIGNED.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
20 October 1, 2021.
