CHAPTER

1 AN ACT concerning

## Real Property – Residential Rental Property Inspection – Remote Video Visual Inspection

4 FOR the purpose of requiring certain local jurisdictions to adopt provisions for the remote 5 <del>video</del> visual inspection of certain residential rental property under certain 6 circumstances; requiring a local provision adopted under this Act to be calculated to 7 achieve a remote video visual inspection substantially comparable to an on-site 8 visual inspection, require inspections to be directed by a certain individual, require 9 a certain verification, and identify the aspects of a property that may be inspected remotely, and require that, before a certain enforcement action may be imposed on 10 a property owner, an on-site inspection occur within a reasonable time after a remote 11 12 visual inspection; authorizing a local jurisdiction to request certain technical assistance from the Maryland Department of Labor; providing that a visual record 13 14 created in accordance with this Act is not a public record; defining certain terms; and generally relating to the remote video visual inspection of residential rental 15 16 property.

WHEREAS, The Maryland Minimum Livability Code under Title 12, Subtitle 2 of the Public Safety Article authorizes in certain circumstances and requires in certain circumstances the inspection of rental housing by counties and municipalities; and

- WHEREAS, Counties and municipalities impacted by COVID-19 continue to develop means to maintain critical safety code oversight while personnel and resources are reallocated, personnel work remotely, and access to shared interior spaces poses an ongoing health risk; and
- 8 WHEREAS, Remote <u>video</u> <u>visual</u> inspection provides an alternative to on–site 9 inspection while allowing scheduling, coordinating, documenting, and processing in a 10 manner that mirrors the on–site inspection process; and
- WHEREAS, Remote <u>video</u> <u>visual</u> inspection allows property inspectors to maintain the quality of residential rental housing remotely, efficiently, and thoroughly while observing safety protocols; now, therefore,
- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 15 That the Laws of Maryland read as follows:

  27 A HOME INSPECTOR TO VISUALLY ASSESS WHETHER THE PROPERTY OR ELEMENT

  RESIDENTIAL RENTAL PROPERTY BY A LICENSED HOME INSPECTOR OR SIMILAR

- 4 (1) DURING A PROTRACTED STATE OF EMERGENCY DECLARED BY 5 THE GOVERNOR: AND
- 6 (2) IN RESPONSE TO A COMPLAINT BY A TENANT OF A DANGEROUS OR
- 7 HAZARDOUS CONDITION IN A RESIDENTIAL RENTAL PROPERTY OR AN ELEMENT OF
- 8 A RESIDENTIAL RENTAL PROPERTY DURING A SEVERE WEATHER EVENT OR A STATE
- 9 OF EMERGENCY OF ANY LENGTH DECLARED BY THE GOVERNOR THAT PREVENTS OR
- 10 RENDERS INADVISABLE AN IN-PERSON INSPECTION.
- 11 (C) A PROVISION ADOPTED BY A LOCAL JURISDICTION UNDER THIS

- 13 (1) BE CALCULATED TO ACHIEVE REMOTE <del>VIDEO</del> VISUAL
- 14 INSPECTIONS THAT ARE SUBSTANTIALLY COMPARABLE TO ON-SITE VISUAL
- 15 INSPECTIONS;
- 16 (2) REQUIRE REMOTE <del>VIDEO</del> VISUAL INSPECTIONS TO BE DIRECTED
- 17 BY A LICENSED HOME INSPECTOR OR SIMILAR PROFESSIONAL DESIGNATED BY THE
- 18 LOCAL JURISDICTION;
- 19 (3) REQUIRE VERIFICATION OF THE LOCATION OF A RESIDENTIAL
- 20 RENTAL PROPERTY TO BE INSPECTED; AND
- 21 (4) IDENTIFY WHAT ASPECTS OF A RESIDENTIAL RENTAL PROPERTY
- 22 MAY BE INSPECTED REMOTELY; AND
- 23 (5) REQUIRE THAT, BEFORE A FINE, PENALTY, OR OTHER
- 24 ENFORCEMENT ACTION MAY BE IMPOSED ON A PROPERTY OWNER, AN ON-SITE
- 25 INSPECTION OCCUR WITHIN A REASONABLE TIME AFTER A REMOTE VISUAL
- 26 INSPECTION.
- 27 (D) A LOCAL JURISDICTION MAY REQUEST TECHNICAL ASSISTANCE FROM
- 28 THE DEPARTMENT TO IMPLEMENT THE PROVISIONS OF THIS SECTION.
- 29 (E) ANY VISUAL RECORD CREATED IN ACCORDANCE WITH THIS SECTION IS
- 30 NOT A PUBLIC RECORD AS DEFINED IN § 4–101 OF THE GENERAL PROVISIONS
- 31 ARTICLE.
- 32 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
