Public Schools - Student Attendance - Excused Absences for Mental Health Needs

FOR the purpose of providing that absences from school for mental health needs are lawful 4 $\mathbf{5}$ absences under certain circumstances; requiring a county board of education to 6 excuse at least a certain number of absences in each quarter of each school year an 7 absence for a student's mental health needs; requiring a certain student to obtain permission from a parent or guardian for a certain absence under certain 8 9 circumstances; prohibiting a county board from requiring a note from a physician to 10 excuse a certain absence; requiring a student who is absent for a certain reason to 11 meet with a school mental health specialist within a certain period of time to discuss a certain topic; defining a certain term; and generally relating to student attendance 12 13in public schools and excused absences.
