## A BILL ENTITLED

1 AN ACT concerning

## Task Force to Study the Maryland Orphans' Courts

FOR the purpose of establishing the Task Force to Study the Maryland Orphans' Courts: providing for the composition, chair, and staffing of the Task Force; prohibiting a 4 member of the Task Force from receiving certain compensation, but authorizing the reimbursement of certain expenses; requiring the Task Force to study and make recommendations regarding certain matters; requiring the Task Force to report its findings and recommendations to the Governor and the General Assembly on or before a certain date; providing for the termination of this Act; and generally relating to the Task Force to Study the Maryland Orphans' Courts.

A member of the Task Force: 5 (e) 6 may not receive compensation as a member of the Task Force; but (1) is entitled to reimbursement for expenses under the Standard State 7 (2)8 Travel Regulations, as provided in the State budget. The Task Force shall: 9 (f) 10 (1) examine the composition and purpose of the orphans' courts in 11 Maryland; 12 (2)review and compare the orphans' courts in each local jurisdiction in Maryland; 13 14 analyze and compare the laws and practices of other states relating to (3) 15 probate courts; 16 examine any other research, analysis, or guidance related to the best **(4)** 17 practices of probate courts; and make recommendations to improve the orphans' courts in Maryland. 18 (5)19 On or before January 1, 2022, the Task Force shall report its findings and 20 recommendations to the Governor and, in accordance with § 2-1257 of the State 21Government Article, the General Assembly. 22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 231, 2021. It shall remain effective for a period of 1 year and, at the end of June 30, 2022, this

Act, with no further action required by the General Assembly, shall be abrogated and of no
