Election Law - Early Voting Centers - Number Required

- FOR the purpose of altering the number of early voting centers certain counties are required to establish; clarifying the process by which one additional early voting center may be established in a county in excess of the number required to be established by law; clarifying the process by which early voting centers are designated in a county; requiring a local board of elections to take into account certain factors when determining the location of an early voting center; and generally relating to early voting centers.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 19 (a) Except as provided under Title 9, Subtitle 3 of this article, during any 20 regularly scheduled primary or general election a voter may vote:

- 14 (c) (1) No later than 6 months before a primary election, the State Board, in
- 15 collaboration with the local board in each county, shall, SUBJECT TO THE APPROVAL OF
- 16 **THE STATE BOARD,** designate each early voting center in that county.
- 17 (2) A LOCAL BOARD SHALL TAKE INTO ACCOUNT THE FOLLOWING
- 18 FACTORS WHEN DETERMINING THE LOCATION OF AN EARLY VOTING CENTER:
- 19 (I) ACCESSIBILITY OF THE EARLY VOTING CENTER TO
- 20 HISTORICALLY DISENFRANCHISED COMMUNITIES, INCLUDING CULTURAL GROUPS,
- 21 ETHNIC GROUPS, AND MINORITY GROUPS;
- 22 (II) PROXIMITY OF THE EARLY VOTING CENTER TO DENSE
- 23 <u>CONCENTRATIONS OF VOTERS;</u>
- 24 (III) ACCESSIBILITY OF THE EARLY VOTING CENTER BY PUBLIC
- 25 TRANSPORTATION;
- 26 (IV) ENSURING EQUITABLE DISTRIBUTION OF EARLY VOTING
- 27 <u>CENTERS THROUGHOUT THE COUNTY; AND</u>
- 28 (V) MAXIMIZING VOTER PARTICIPATION, INCLUDING THROUGH
- 29 THE USE OF COMMUNITY CENTERS AND PUBLIC GATHERING PLACES AS LOCATIONS

- 31 (d) Each early voting center shall be open for voting as follows:

8 9	(e) Each early voting center shall satisfy the requirements of § 10–101 of this title.
10 11 12	(f) Beginning 30 days prior to each early voting period the State Board and each local board shall undertake steps to inform the public about early voting and the location of early voting centers in each county, including:
13	(1) a series of public service media announcements;
14	(2) mailings to all registered voters in each county; and
15	(3) other measures as appropriate.
16 17	(g) Except as expressly provided in this section, any provision of this article that applies to voting on election day also applies to early voting.
18 19	(h) The State Board shall adopt regulations and guidelines in accordance with the requirements of this section for the conduct of early voting.
20 21	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2021.
