CHAPTER

1 AN ACT concerning

2 Public Schools - Centers for Disease Control and Prevention Surveys - Revisions

FOR the purpose of requiring the State Department of Education, in coordination with the 4 5 Maryland Department of Health, to establish procedures for the administration of 6 certain Centers for Disease Control and Prevention surveys to certain students; 7 repealing the authority of the State Department of Education to omit a certain 8 amount of survey questions under certain circumstances; requiring that certain 9 actions taken by the State Department of Education be taken in coordination with the Maryland Department of Health; requiring the State Department of Education, 10 11 in coordination with the Maryland Department of Health, to include in the survey certain tiers and at least a certain number of certain questions; requiring, within a 12 certain period of time, the Maryland Department of Health to publish a certain data 13 14 summary and trends report on certain data requiring that a certain report submitted 15 by the Maryland Department of Health to the Governor and the General Assembly by a certain date in certain years include, beginning in a certain year, a certain data 16 summary and trends report on certain data; requiring the Maryland Department of 17 18 Health to publish a certain data summary and trends report on certain data on or 19 before a certain date; defining a certain term; making a technical change; and 20 generally relating to Centers for Disease Control and Prevention surveys.

- 1 C. The student's name will not be required on the survey 2 response sheet; and 3 D. The survey is designed to identify risk behaviors that may 4 include safety behaviors such as use of helmets and seat belts, depression and mental 5 health, use of tobacco, alcohol, or other drugs, nutrition and physical activity, and sexual 6 behavior; and 7 2. Explains how a parent can obtain a copy of the survey 8 questions that will be administered and more information regarding the survey, including the mailing address, telephone number, and website address of the Centers for Disease 9 10 Control and Prevention; and 11 Subject to subsection (d) of this section, a denial of permission (ii) 12 form that may be returned by the parent to the school. 13 (d) (1) For the academic year during which the survey will be conducted, the 14 denial of permission form shall be a part of the request for emergency contact information 15 that is distributed by the public school to each student or parent or guardian of the student. 16 The denial of permission form shall be distributed only to a student or (2)17 the parent or guardian of a student who may be subject to the survey administered under 18 this section. 19 WITHIN 6 MONTHS AFTER RECEIVING CENTERS FOR DISEASE CONTROL 20 AND PREVENTION YOUTH RISK BEHAVIOR SURVEY DATA ON ADVERSE CHILDHOOD 21EXPERIENCES AND POSITIVE CHILDHOOD EXPERIENCES FROM THE CENTERS FOR 22 DISEASE CONTROL, THE MARYLAND DEPARTMENT OF HEALTH SHALL PUBLISH A STATE AND COUNTY LEVEL DATA SHMMARY AND TRENDS REPORT ON THE DATA. 23 Article - Health - General 242513–1004. 26 (a) Beginning in fiscal year 2007 and in every second year thereafter, the 27 Department shall conduct a Tobacco Study which shall measure the same factors that are set forth in § 13–1003(c) of this subtitle and use the same methodology or model that was 28used for the Baseline Tobacco Study. 29 30 To carry out the evaluation and surveillance functions of this subtitle, the Department may conduct any other tobacco study measuring the factors set forth in § 31 13–1003(c) of this subtitle and using a methodology or model that is consistent with but 32need not be identical to that used to conduct the Baseline Tobacco Study. 33
- 34 (c) (1) Subject to paragraphs (2) through (4) of this subsection, the 35 Department shall contract with a higher education institution or private entity to conduct 36 the Biennial Tobacco Study.

3 4	(3) The Department may contract with an entity to conduct one or more biennial tobacco studies.
5 6	(4) The Department shall use the criteria established in § 13–1003(e)(5) of this subtitle as a guide in administering the request for proposal process.
7 8 9	(d) On or before May 31 of each even—numbered fiscal year, beginning in fiscal year 2008, the Department shall submit a report to the Governor and, subject to § 2–1257 of the State Government Article, the General Assembly on [the]:
