A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore County – Archery Hunting – Safety Zone**

3 FOR the purpose of altering the size of the safety zone for archery hunters in Baltimore
4 County within which archery hunting may not take place except under certain
5 circumstances; requiring an archery hunter in Baltimore County to use a tree stand
6 when hunting any wild bird or mammal within a certain distance of certain
7 buildings; and generally relating to the archery hunting safety zone in Baltimore
8 County.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Natural Resources**

17 10–410.

18 (g) (1) Except as provided in paragraphs (2) and (3) of this subsection, a
19 person, other than the owner or occupant, while hunting for any wild bird or mammal may
20 not shoot or discharge any firearm or other deadly weapon within 150 yards, known as the
21 “safety zone”, of a dwelling house, residence, church, or other building or camp occupied by
22 human beings, or shoot at any wild bird or mammal while it is within this area, without
23 the specific advance permission of the owner or occupant.

24 (2) A person, while hunting for any wild bird or mammal, may not shoot or
25 discharge any firearm within 300 yards of a public or nonpublic school during school hours

1 or at a time when a school–approved activity is taking place.

2 (3) (i) For archery hunters in **BALTIMORE COUNTY**, Calvert County,
3 Carroll County, Cecil County, Frederick County, Harford County, Montgomery County, St.
4 Mary’s County, or Washington County, the safety zone described in paragraph (1) of this
5 subsection extends for 50 yards from a dwelling house, residence, church, or any other
6 building or camp occupied by human beings.

7 (ii) For archery hunters in Anne Arundel County, the safety zone
8 described in paragraph (1) of this subsection extends for 100 yards from a dwelling house,
9 residence, church, or any other building or camp occupied by human beings.

10 (4) During any open hunting season, a person, other than the owner or
11 occupant, may not hunt or chase willfully any wild bird or mammal within the safety zone
12 without the specific advance permission of the owner or occupant.

13 (5) In **BALTIMORE COUNTY AND** Harford County, an archery hunter
14 shall use a tree stand when hunting any wild bird or mammal within 50 to 100 yards of a
15 dwelling house, residence, church, public or nonpublic school, or other building or camp
16 occupied by human beings.

17 (6) In Montgomery County or Washington County, an archery hunter shall
18 be in an elevated position that allows the hunter to shoot in a downward trajectory when
19 hunting any wild bird or mammal within 50 to 100 yards of a dwelling house, residence,
20 church, public or nonpublic school, or other building or camp occupied by human beings.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
22 1, 2021.
