## 3 FOR the purpose of establishing the Real Property Transfer—on—Death Deed Task Force; providing for the composition, chair, and staffing of the Task Force; prohibiting a 4 5 member of the Task Force from receiving certain compensation, but authorizing the 6 reimbursement of certain expenses; requiring the Task Force to study and make 7 recommendations regarding certain matters; requiring the Task Force to report its 8 findings and recommendations to the Governor and the General Assembly on or 9 before a certain date; providing for the termination of this Act; and generally relating to the Real Property Transfer-on-Death Deed Task Force. 10 11 SECTION 1. - SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2021. It shall remain effective for a period of 2 years and, at the end of June 30, 2023, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
