# A BILL ENTITLED

### 1 AN ACT concerning

# Washington County - Nursing Homes and Assisted Living Programs - Essential Caregivers

- FOR the purpose of requiring each nursing home and assisted living program in 4  $\mathbf{5}$ Washington County to establish certain policies and procedures authorizing certain 6 visitation from an essential caregiver and relating to the designation and use of an 7 essential caregiver; authorizing nursing homes and assisted living programs to 8 consult with the local health officer when establishing the policies and procedures; 9 requiring certain nursing homes and assisted living programs to consult with certain 10 administrators and staff to make a certain determination; requiring certain nursing 11 homes and assisted living programs to consult with certain patients or residents and 12essential caregivers to identify a certain schedule; requiring certain nursing homes 13 and assisted living programs to ensure that certain scheduling considers the number 14of essential caregivers in the nursing home or assisted living program at any given 15time and designates a certain point of entry; requiring certain nursing homes and assisted living programs to require essential caregivers to abide by certain rules 1617adopted by the nursing home or assisted living program; requiring an essential 18 caregiver to inform the staff of the nursing home or assisted living program if the 19essential caregiver develops certain symptoms; authorizing an essential caregiver to 20transport a certain patient or resident for a certain purpose; prohibiting an essential 21 caregiver from visiting a patient or resident if the patient or resident is quarantined; 22authorizing certain nursing homes and assisted living programs to restrict or revoke 23essential caregiver status under certain circumstances; providing for the application 24of this Act; defining certain terms; and generally relating to essential caregivers in 25nursing homes and assisted living programs.

1 (D) EACH NURSING HOME AND ASSISTED LIVING PROGRAM SHALL:  $\mathbf{2}$ (1) **ESTABLISH POLICIES AND PROCEDURES FOR HOW TO DESIGNATE** AND USE ONE OR MORE ESSENTIAL CAREGIVERS FOR EACH PATIENT OR RESIDENT; 3 (2) 4 **CONSULT WITH THE ADMINISTRATOR OF THE NURSING HOME OR**  $\mathbf{5}$ ASSISTED LIVING PROGRAM OR OTHER STAFF AS APPROPRIATE TO DETERMINE IF 6 AN INDIVIDUAL MEETS THE CRITERIA FOR AN ESSENTIAL CAREGIVER; 7 (3) CONSULT WITH THE RESIDENT OR PATIENT AND THE ESSENTIAL 8 CAREGIVER TO IDENTIFY A DAILY SCHEDULE; 9 (4) ENSURE THAT THE SCHEDULING OF ESSENTIAL CAREGIVER 10 VISITS CONSIDERS THE NUMBER OF ESSENTIAL CAREGIVERS IN THE NURSING HOME 11 OR ASSISTED LIVING PROGRAM AT ANY GIVEN TIME; 12(5) **DESIGNATE A POINT OF ENTRY WHERE AN ESSENTIAL CAREGIVER** 13 SIGNS IN TO THE NURSING HOME OR ASSISTED LIVING PROGRAM AND UNDERGOES 14 **REQUIRED SCREENING; AND** 15**REQUIRE AN ESSENTIAL CAREGIVER TO ABIDE BY RULES AND** (6) 16 POLICIES ADOPTED BY THE NURSING HOME OR ASSISTED LIVING PROGRAM TO 17ENSURE PATIENT AND RESIDENT SAFETY. 18 **(E)** AN ESSENTIAL CAREGIVER SHALL, IN A TIMELY MANNER, INFORM THE STAFF OF THE NURSING HOME OR ASSISTED LIVING PROGRAM IF THE ESSENTIAL 19 20CAREGIVER DEVELOPS ANY SYMPTOM OF A POTENTIALLY TRANSMISSIBLE ILLNESS. AN ESSENTIAL CAREGIVER MAY TRANSPORT THE PATIENT OR RESIDENT 21**(F)** 22OUTSIDE THE NURSING HOME OR ASSISTED LIVING PROGRAM FOR ESSENTIAL 23MEDICAL APPOINTMENTS. 24(G) IF A PATIENT OR RESIDENT IS QUARANTINED, AN ESSENTIAL 25CAREGIVER MAY NOT VISIT THE PATIENT OR RESIDENT UNTIL THE QUARANTINE 26ENDS.

(H) A NURSING HOME OR ASSISTED LIVING PROGRAM MAY RESTRICT OR
REVOKE ESSENTIAL CAREGIVER STATUS IF THE ESSENTIAL CAREGIVER DOES NOT
FOLLOW THE RULES AND POLICIES OF THE NURSING HOME OR ASSISTED LIVING
PROGRAM OR THE DIRECTION OF STAFF.

#### HOUSE BILL 962

1 (1) "Assisted living program" means a residential or facility-based 2 program that provides housing and supportive services, supervision, personalized 3 assistance, health-related services, or a combination thereof that meets the needs of 4 individuals who are unable to perform or who need assistance in performing the activities 5 of daily living or instrumental activities of daily living in a way that promotes optimum 6 dignity and independence for the individuals.
