Vehicle Laws – Driving in Right–Hand Lanes – Interstate Highways in Rural Areas

- FOR the purpose of requiring the driver of a vehicle traveling slower than the general speed 4 5 of traffic on certain interstate highways to drive the vehicle in the right-hand lanes 6 under certain circumstances; requiring the Motor Vehicle Administration to include 7 certain information in the State's driver education curriculum; requiring the State 8 Highway Administration to inform drivers of certain requirements by posting certain 9 signage and providing certain notice in a certain manner; requiring the Motor 10 Vehicle Administration and the State Highway Administration to provide a certain 11 report to certain committees of the General Assembly; prohibiting the issuance of a 12 citation for a violation of this Act; providing for the construction of this Act; defining 13 certain terms; and generally relating to requirements to drive in the right-hand lanes of a roadway. 14

AND BE IT FURTHER ENACTED, That, on or before December 1, 2023, the Motor Vehicle Administration and the State Highway Administration shall report jointly to the Senate Judicial Proceedings Committee and the House Environment and Transportation Committee, in accordance with § 2–1257 of the State Government Article, on the efforts made to provide driver education and notice throughout the State required under this Act. SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2021.
