1 AN ACT concerning

Home Energy Assistance - Critical Medical Needs Program - Power to the People Pilot Program

4 FOR the purpose of requiring the Office of Home Energy Programs, in coordination with $\mathbf{5}$ the United Way of Central Maryland and the Fuel Fund of Maryland, to establish 6 the Power to the People Pilot Program on or before a certain date; stating the purpose 7 of the Pilot Program; requiring the Pilot Program to provide training for certain 8 individuals to serve as navigators under the Critical Medical Needs Program; 9 requiring the United Way of Central Maryland to develop a certain screening intake 10 process; requiring certain intake specialists to perform certain duties; requiring the 11 Fuel Fund of Maryland to provide certain services; requiring the Governor to include 12 a certain amount in the annual State budget for the Pilot Program; requiring that 13certain funds be used in a certain manner; altering a certain definition; defining a 14 certain term; providing for the termination of this Act; and generally relating to the 15Power to the People Pilot Program.

- 21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

27	(2) The Office shall implement and administer the CMN Program.
28 29 30 31	(3) In administering the CMN Program, the Office shall partner with the Office of People's Counsel, the Fuel Fund of Central Maryland, the Cancer Support Foundation, electric and gas companies, nonprofit organizations, other State agencies, the health care community, and any other organization that the Office determines appropriate.

1 (4) The purpose of the CMN Program is to reduce the barriers to the energy 2 assistance application process for critical medically vulnerable individuals and their 3 households in obtaining State and federal financial assistance for their electric, gas, or 4 other energy source bills so that their electric, gas, or other energy source service continues 5 or is restored.

6 (c) (1) The CMN Program shall facilitate assistance to critical medically 7 vulnerable individuals and their households in obtaining State and federal financial 8 assistance for their electric, gas, or other source energy bills through navigators.

9 (2) The Office shall determine qualifications and establish training 10 requirements for navigators.

11 (3) The Office shall train navigators or facilitate the training of navigators12 by others.

13 (d) In accordance with the requirements set forth in the Code of Maryland 14 Regulations, the Office shall work with electric and gas companies to implement, for critical 15 medically vulnerable individuals:

16 (1) a medical hold on electric or gas service or an expedited process to grant 17 the extension of electric or gas service for those who will have their electric or gas services 18 terminated; and

19 (2) an expedited process for the restoration of electric or gas service for 20 those who have had their electric or gas service terminated.

21 (e) The Office shall establish a tracking system of the status of critical medically 22 vulnerable individuals who participate in the CMN Program.

(F) (1) ON OR BEFORE JULY 1, 2022, THE OFFICE, IN COORDINATION
WITH THE UNITED WAY OF CENTRAL MARYLAND AND THE FUEL FUND OF
MARYLAND, SHALL ESTABLISH THE POWER TO THE PEOPLE PILOT PROGRAM.

26 (2) THE PURPOSE OF THE PILOT PROGRAM IS TO EXPAND ACCESS TO 27 THE CMN PROGRAM.

(3) THE PILOT PROGRAM SHALL PROVIDE TRAINING FOR 2–1–1
 MARYLAND UNITED WAY HELPLINE INTAKE SPECIALISTS AND CASE MANAGERS TO
 SERVE AS NAVIGATORS.

(4) THE UNITED WAY OF CENTRAL MARYLAND SHALL ESTABLISH A
 SCREENING INTAKE PROCESS TO IDENTIFY CALLERS TO THE 2–1–1 MARYLAND
 UNITED WAY HELPLINE WHO MAY BE CRITICAL MEDICALLY VULNERABLE
