1 AN ACT concerning

2 **Prince George's County – Tax Sales – Limited Auction**

3 **PG 413–21**

4 FOR the purpose of altering the types of properties for which the tax collector in Prince
5 George's County shall conduct a certain limited auction prior to conducting a public
6 auction for property subject to tax liens; altering eligibility requirements for certain
7 individuals to submit bids in a certain limited auction; providing that any payments
8 received for a certain tax sale certificate that is void under certain circumstances
9 shall be applied to any taxes on the property that are in arrears; and generally
10 relating to tax sales of property in Prince George's County.

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 That the Laws of Maryland read as follows:

2 **Article – Tax – Property**

3 14–817.

4 (d) (1) This subsection applies only in Prince George’s County.

5 (2) In addition to the sale by public auction required under this section, the
6 collector shall conduct a sale by limited auction prior to the public auction **OF ABANDONED**
7 **PROPERTY CONSISTING OF EITHER A VACANT LOT OR IMPROVED PROPERTY CITED**
8 **AS VACANT AND UNFIT FOR HABITATION ON A HOUSING OR BUILDING VIOLATION**
9 **NOTICE.**

10 (3) The sale by limited auction required under paragraph (2) of this
11 subsection shall be open to bids only from an individual who is:

12 (i) employed in a public school located in Prince George’s County;

13 (ii) employed by the Prince George’s County Police Department;

14 (iii) employed by the Prince George’s County Fire Department;

15 (iv) employed by the Prince George’s County Office of the Sheriff;

16 (v) employed by the Prince George’s County Department of
17 Corrections;

18 (vi) employed by the Prince George’s County government in a
19 position not included under item (i), (ii), (iii), (iv), or (v) of this paragraph;

20 (vii) employed by ~~the~~ A federal government AGENCY LOCATED IN
21 PRINCE GEORGE’S COUNTY;

22 (viii) employed by a municipal government in Prince George’s County;

23 (ix) a veteran of any branch of the armed forces of the United States
24 who has received an honorable discharge AND IS EMPLOYED IN PRINCE GEORGE’S
25 COUNTY; or

26 (x) a resident of Prince George’s County.

27 (4) The collector shall include the date, time, and location of the limited
28 auction required under this subsection in any notice of sale at public auction required under
29 this subtitle.

1 (5) (i) The limited auction shall be subject to the same requirements for
2 a public auction under this section.

3 (ii) The purchase of property at a limited auction shall be considered
4 the same as a purchase at public auction under this section and shall be subject to the
5 requirements of this subtitle in the same manner as a sale at public auction.

6 (iii) The collector shall establish a system to verify that individuals
7 placing bids on property at the limited auction are eligible to do so under paragraph (3) of
8 this subsection.

9 (iv) A certificate of sale for property purchased at a limited auction
10 shall be void if the purchaser was not an eligible participant under paragraph (3) of this
11 subsection.

12 (v) If a certificate of sale is void under subparagraph (iv) of this
13 paragraph[,]:

14 **1. ANY RIGHT OR INTEREST OF THE HOLDER OF THE**
15 **CERTIFICATE OF SALE IS VOID AND ANY PAYMENT RECEIVED BY THE COLLECTOR AT**
16 **THE SALE SHALL BE FORFEITED AND APPLIED TO ANY TAXES IN ARREARS ON THE**
17 **PROPERTY; AND**

18 **2.** the property shall be listed at the next limited or public
19 auction held if the property is still eligible to be sold under this subtitle.

20 (6) Property offered for sale during a limited auction that is not sold shall
21 be offered for sale at public auction in accordance with this section.

23 (h) The holder of a certificate of sale for abandoned property consisting of either
24 a vacant lot or improved property cited as vacant and unfit for habitation on a housing or
25 building violation notice in Prince George's County that is sold under § 14-817(d) of this
26 subtitle may file a complaint to foreclose all rights of redemption in the property at any
27 time after the date of sale.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
29 ~~October~~ July 1, 2021.
