States of Emergency – Emergency Procurement and Budget Amendments – Notice and Authorization

FOR the purpose of requiring the Governor or the head of a certain unit to provide certain notice to the Legislative Policy Committee within a certain time frame when authorizing a certain emergency procurement during a state of emergency under certain circumstances; requiring the Office of Legislative Audits to perform a certain audit within a certain time frame under certain circumstances; requiring the Governor or the head of a certain unit to provide a copy of a certain procurement contract to the Legislative Policy Committee under certain circumstances; authorizing the Legislative Policy Committee to request that the Office of Legislative Audits perform a certain audit under certain circumstances; requiring the Governor to provide certain notice to certain persons within a certain time frame after suspending the effect of a certain statute or rule or regulation under certain circumstances; authorizing a certain appropriation to be increased by budget amendment if the Board of Public Works makes a certain declaration; prohibiting the Governor from suspending the effects of certain provisions under certain eireumstances; and generally relating to emergency procurements and the Governor's authority to suspend the effect of a statute, rule, or regulation during a state of emergency.
