- 4 FOR the purpose of authorizing an alcoholic beverages inspector to issue a citation in $\mathbf{5}$ Howard County; requiring an inspector to complete a training program in the use of 6 arrest authority and pertinent police procedures; prohibiting an inspector from 7 carrying a firearm in the performance of the inspector's duties; requiring the Howard 8 County Police Department to employ certain inspectors, rather than requiring the 9 Chief of the County Police Department to provide a sworn member of the County 10 Police Department as an inspector; requiring the Chief of the County Police 11 Department to have certain authority over the hiring of inspectors; and generally 12relating to alcoholic beverages in Howard County.

26 27 28	(3) In Anne Arundel County, Harford County, HOWARD COUNTY , Kent County, Montgomery County, Prince George's County, and Talbot County, the inspector may not carry a firearm in the performance of the inspector's duties.
29 30	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2021.
