1 AN ACT concerning

2 **Baltimore City – Visit Baltimore – Appropriation Calculation**

3 FOR the purpose of altering the method by which a certain annual appropriation in the
4 Baltimore City budget to Visit Baltimore is calculated; altering the termination date
5 of the Visit Baltimore appropriation; providing for a delayed effective date; and
6 generally relating to hotel room taxes and convention center marketing and tourism
7 promotion in Baltimore City.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **The Charter of Baltimore City**

19 Article II – General Powers

 2 Maryland or by any Public General or Public Local Laws of the State of Maryland; and in
 3 particular, without limitation upon the foregoing, shall have power by ordinance, or such
 4 other method as may be provided for in its Charter, subject to the provisions of said
 5 Constitution and Public General Laws:

7 (e) (1) For each fiscal year beginning on or after July 1, 1997 but before July
 8 1, ~~[2022]~~ **2027**, the Mayor and City Council shall appropriate from its General Fund to
 9 Visit Baltimore for the marketing and operations of the Convention Center and tourism
 10 promotion an amount equal to at least 40% of the proceeds of any hotel room tax imposed.

11 (2) If the appropriation made for any fiscal year pursuant to paragraph (1)
 12 of this subsection is less than the amount required when compared to [actual receipts for
 13 the completed fiscal year] **THE AVERAGE OF THE ACTUAL HOTEL ROOM TAX RECEIPTS**
 14 **RECEIVED FROM THE IMMEDIATELY PRECEDING 3-YEAR ROLLING AVERAGE**, the
 15 difference shall be added to the appropriation to be made for the second succeeding fiscal
 16 year. If the appropriation made for any fiscal year pursuant to paragraph (1) of this
 17 subsection is more than the amount required when compared to [actual receipts for the
 18 completed fiscal year] **THE AVERAGE OF THE ACTUAL HOTEL ROOM TAX RECEIPTS**
 19 **RECEIVED FROM THE IMMEDIATELY PRECEDING 3-YEAR ROLLING AVERAGE**, the
 20 difference may be deleted from the appropriation to be made for the second succeeding fiscal
 21 year.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
