Public Health – Maryland Commission on Health Equity (The Shirley Nathan–Pulliam Health Equity Act of 2021)

20 **Preamble**

WHEREAS, Race is a social construct with no biological basis that artificially divides 22 people into distinct groups based on characteristics such as physical appearance, ancestral heritage, cultural affiliation, and the social, economic, and political needs of a society at a 23 given period; and 24

WHEREAS, Racism is a social system with multiple dimensions that include individual racism that is internalized or interpersonal, systemic racism that is institutional or structural, and a system of structuring opportunity and assigning value based on the social interpretation of how one looks; and

WHEREAS, Racism unfairly disadvantages specific individuals and communities while unfairly giving advantages to other individuals and communities and undermines society as a whole through the waste of human resources necessary to promote prosperity and development in Maryland and elsewhere; and

WHEREAS, Racism is rooted in the foundation of America, from the time chattel slavery began in the 1600s, to the Jim Crow era, to the declaration of the war on drugs that eventually led to the mass incarceration of Black people, and it has remained a presence in American society while subjecting Black, Indigenous, and People of Color to hardships and disadvantages in every aspect of life; and

1	WHEREAS, The American Public Health Association, National Association of						
2	County and City Health Officials, and the American Academy of Pediatrics have declared						
3	racism as a public health crisis; and						
4	WHEREAS, Communities of color, working class residents, and individuals with						
5	disabilities are more likely to experience poor health outcomes as a consequence of their						
6	social determinants of health; and						
7	WHEREAS, Racism causes persistent discrimination and disparate outcomes in						
8	many areas of life, including housing, education, employment, criminal justice and						
9	incarceration, family stability, economic opportunity, access to health care, public safety,						
10	environmental safety, inadequate nutrition, voters' rights, and under-resourced						
11	recreational and health care facilities; and						
12	WHEREAS, More than 100 studies have linked racism to worse health outcomes;

14	WHEREAS, Racism exacerbates health disparities among Black, Hispanic, and						
15	Native American residents, including a greater risk of heart disease, stroke, infant						
16	mortality, maternal mortality, lower birth weight, obesity, hypertension, type 2 diabetes,						
17	cancers, respiratory diseases, and autoimmune diseases; and						
18	WHEREAS, Specific physical and behavioral health conditions stemming from						
19	racism include depression, anxiety, anger, fear, trauma, terror, and long-term physical and						
20	mental health impairments; and						
21	WHEREAS, The COVID-19 crisis and ongoing protests against police brutality have						
22	helped to highlight now, more than ever, that racism, not race, causes disparities for black
