## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Correctional Education – Changes to Mandatory Education Requirements**

3 FOR the purpose of increasing the number of required days for a certain mandatory  
4 education program for correctional institutions in the Division of Correction; and  
5 generally relating to correctional education.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
17 That the Laws of Maryland read as follows:

18 **Article – Labor and Employment**

1 (a) (1) The Correctional Education Council shall develop and recommend an  
2 educational and workforce training program for each correctional institution in the Division  
3 of Correction.

4 (2) The programs shall meet the special needs and circumstances of the  
5 inmates in each correctional institution.

6 (3) If the Justice Reinvestment Oversight Board makes a funding  
7 recommendation under § 9–3207(b)(6) of the State Government Article, a post–secondary  
8 education and workforce training program, in accordance with the funding  
9 recommendation, shall provide inmates with the requisite training, certifications, and  
10 experience to obtain careers in in–demand job sectors.

11 (b) (1) The Council shall adopt regulations for all correctional institutions in  
12 the Division of Correction for the implementation of a mandatory education program for all  
13 inmates who fail to attain a minimum educational standard as set forth in this subsection.

14 (2) The regulations adopted by the Council shall:

15 (i) require that the educational standard shall be the attainment of  
16 a General Educational Development (GED) diploma or a verified high school diploma;

17 (ii) apply only to any inmate who:

18 1. was received by the Division of Correction after July 1,  
19 1987;

20 2. has 18 months or more remaining to be served before a  
21 mandatory supervision release date;

22 3. is not exempted due to a medical, developmental, or  
23 learning disability; and

24 4. does not possess a General Educational Development  
25 (GED) diploma or a verified high school diploma; and

26 (iii) require any inmate who is not exempted under item (ii)3 of this  
27 paragraph to participate in:

28 1. the mandatory education program for at least [120] **240**  
29 calendar days; or

30 2. a workforce skills training program.

31 (3) The Division of Correction shall report to the Parole Commission the  
32 academic progress of an inmate in the mandatory education program.

1           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
2   October 1, 2021.
