SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

16 (b) Except as provided in subsection (c) of this section, a person who violates 17 subsection (a) of this section is guilty of the misdemeanor of assault in the second degree 18 and on conviction is subject to imprisonment not exceeding 10 years or a fine not exceeding 19 \$2,500 or both.

20 (c) (1) In this subsection, "physical injury" means any impairment of physical 21 condition, excluding minor injuries.
