## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Business Regulation – Retail Pet Stores – Modifications**  
3 **(No More Puppy- and Kitten-Mills Act of 2021)**

4 FOR the purpose of altering the definition of “retail pet store” to include a broker that  
5 transfers dogs or cats for resale by another person for purposes of certain provisions  
6 of law regulating retail pet stores; clarifying a certain prohibition on the sale of cats  
7 or dogs by retail pet stores; repealing a certain statement of intent of the General  
8 Assembly; altering certain definitions; repealing a certain definition; and generally  
9 relating to retail pet stores.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
19 That the Laws of Maryland read as follows:

20 **Article – Business Regulation**

2 (a) In this subtitle the following words have the meanings indicated.

3 (b) “Animal control unit” has the meaning stated in § 10-617 of the Criminal Law  
4 Article.

5 (c) (1) “Animal welfare organization” means a nonprofit organization:

6 (i) that has tax exempt status under § 501(c)(3) of the U.S. Internal  
7 Revenue Code; and

8 (ii) whose mission and practice is the rescue of animals and the  
9 placement of those animals in permanent homes.

10 (2) “Animal welfare organization” does not include an organization that  
11 obtains animals from a breeder or broker in exchange for payment or compensation.

12 (d) “Breeder” means a person who breeds or raises dogs **OR CATS** to sell,  
13 exchange, or otherwise transfer to the public.

14 (e) “Broker” means a person who transfers dogs **OR CATS** for resale by another  
15 person.

16 (f) [“Offer for sale” includes to sell, offer to transfer, offer for adoption, advertise  
17 for the sale, barter, auction, give away, or otherwise dispose of a domestic animal.

18 (g) (1) “Retail pet store” means:

19 (I) a for-profit establishment [open to the public] that sells or offers  
20 for sale domestic animals to be kept as household pets; **OR**

21 (II) **A BROKER.**

22 (2) **“RETAIL PET STORE” DOES NOT INCLUDE AN ESTABLISHMENT AT**  
23 **WHICH:**

24 (I) **THE ANIMALS SOLD AT THE ESTABLISHMENT WERE BORN AT**  
25 **THE ESTABLISHMENT; AND**

26 (II) **A COMPLETED SALE, TRANSFER, OR DISPOSITION OF A CAT**  
27 **OR DOG IS CONDUCTED IN PERSON WITH BOTH PARTIES PHYSICALLY PRESENT AT**  
28 **THE SAME LOCATION.**

29 19-703.

1 (a) A retail pet store may not [offer for sale] **SELL** or otherwise transfer or dispose  
2 of cats or dogs.

3 (b) This section may not be construed to prohibit a retail pet store from  
4 collaborating with an animal welfare organization or animal control unit to offer space for  
5 these entities to showcase cats or dogs for adoption.

6 **Chapter 237 of the Acts of 2018**

7 **[SECTION 2. AND BE IT FURTHER ENACTED, That it is the intent of the General**  
8 **Assembly that:**

9 (1) animal welfare organizations initiate contact with retail pet stores, as  
10 provided under § 19–703(b) of the Business Regulation Article, as enacted by Section 1 of  
11 this Act, that will no longer be able to offer for sale cats and dogs, to facilitate collaboration  
12 to showcase cats and dogs for:

13 (i) adoption from an animal control unit or an animal welfare  
14 organization; or

15 (ii) purchase from local breeders; and

16 (2) the Senate Finance Committee and the House Economic Matters  
17 Committee monitor the implementation of this Act.]

18 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July**  
19 **1, 2021.**
