25WHEREAS, Evictions exacerbate the public health crisis posed by COVID-19; and

26WHEREAS, Evictions create significant costs for state and local government related 27to shelter funding, education funding, health care provided in hospitals instead of 28community-based providers, transportation costs for homeless youth, and foster care; and

29WHEREAS, A study of eviction actions in one local jurisdiction found that while only 30 1% of tenants are represented in eviction proceedings, approximately 96% of landlords are represented by an attorney or specialized agent in eviction proceedings; and 31

32WHEREAS, Evictions have a disparate impact on black and brown households in the 33 State; and

34WHEREAS, The General Assembly seeks to end the disparate impact of evictions 35 based on race and gender; and
