### CHAPTER \_\_\_\_\_

1 AN ACT concerning

### 2 **Student and Military Voter Empowerment Act**

3 FOR the purpose of requiring a local board of elections to contact and obtain input from  
4 certain large residential institutional communities when establishing precinct  
5 boundaries and designating the location of polling places; requiring the State Board  
6 of Elections to maintain a page on its website that includes certain information about  
7 and links regarding voter registration and voting by students enrolled in institutions  
8 of higher education; requiring the State Board to establish a process for an individual  
9 to submit a certain federal post card application electronically and use a certain  
10 common access card to sign a certain federal post card application; *providing that a*  
11 *certain process may allow the use of a common access card only for certain purposes;*  
12 *prohibiting a certain process from allowing an individual to apply to register to vote*  
13 *solely using the card;* requiring a public institution of higher education to designate  
14 a staff member as the student voting coordinator; requiring the student voting  
15 coordinator to develop and implement a student voting plan to increase student voter

 22 than a certain number of clicks on a certain link to the online voter registration  
 23 system in the preceding calendar year; requiring certain private nonprofit  
 24 institutions of higher education that receive funding from the State to submit a  
 25 certain report to the Maryland Independent College and University Association  
 26 regarding voter registration on or before a certain date each year; requiring the  
 27 Maryland Independent College and University Association to submit a certain report  
 28 summarizing information regarding voter registration at certain private nonprofit  
 29 institutions of higher education to certain committees of the General Assembly on or  
 30 before a certain date each year; defining certain terms; making conforming changes;  
 31 and generally relating to voter registration and voting.

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
9 That the Laws of Maryland read as follows:

10 **Article – Election Law**

11 1–101.

12 (a) In this article the following words have the meanings indicated unless a  
13 different meaning is clearly intended from the context.

14 **(BB–1) “INSTITUTION OF HIGHER EDUCATION” HAS THE MEANING**  
15 **STATED IN § 10–101 OF THE EDUCATION ARTICLE.**

16 **[(bb–1)] (BB–2)** “Legislative party caucus committee” means a political  
17 committee that is established to promote the election of candidates of a single political party  
18 to one of the two Houses of the General Assembly.

19 2–303.

20 (a) (1) Subject to [paragraph] **PARAGRAPHS (2) AND (3)** of this subsection, as  
21 it deems it expedient for the convenience of voters, a local board may:

22 (i) create and alter the boundaries for precincts in the county;

23 (ii) designate the location for polling places in any election district,  
24 ward, or precinct in the county; and

25 (iii) combine or abolish precincts.

26 (2) (i) Except as provided under subparagraph (iii) of this paragraph, a  
27 local board shall establish a separate precinct on campus or within one-half mile of the  
28 campus to specifically serve a public or private institution of higher education if the local  
29 board determines that at least 500 students, faculty, and staff who attend or work at the  
30 institution are registered voters in the precinct in which the institution is located.

(ii) If, in accordance with subparagraph (i) of this paragraph, a polling place is established at an institution of higher education that receives State funds, that institution shall:

1. provide without charge to the local board a facility for use as a polling place that meets all applicable requirements under this article and as established by the State Board; and

2. provide assistance to the local board in recruiting election judges to staff the polling place.

(iii) A local board may not be required to establish a separate precinct as provided under subparagraph (i) of this paragraph if there is an established precinct within one-half mile of the public or private institution of higher education's campus that serves the voters who attend or work at the public or private institution of higher education.

**(3) WHEN A LOCAL BOARD IS ESTABLISHING PRECINCT BOUNDARIES AND DESIGNATING THE LOCATION OF POLLING PLACES, THE LOCAL BOARD SHALL CONTACT AND OBTAIN INPUT FROM LARGE RESIDENTIAL INSTITUTIONAL COMMUNITIES INCLUDING INSTITUTIONS OF HIGHER EDUCATION, CONTINUING CARE RETIREMENT COMMUNITIES, SENIOR COMMUNITIES, AND MILITARY INSTALLATIONS.**

**THE STATE BOARD SHALL MAINTAIN A PAGE ON ITS WEBSITE THAT:**

**(1) EXPLAINS IN PLAIN, EASILY UNDERSTANDABLE LANGUAGE THE REQUIREMENTS FOR STUDENTS ENROLLED IN INSTITUTIONS OF HIGHER EDUCATION TO REGISTER TO VOTE IN THE STATE; AND**

**(2) INCLUDES LINKS TO INFORMATION REGARDING VOTER REGISTRATION REQUIREMENTS AND VOTING BY ABSENTEE BALLOT IN OTHER STATES IN WHICH STUDENTS ENROLLED IN INSTITUTIONS OF HIGHER EDUCATION MAY RESIDE.**

**(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.**

**(2) "COMMON ACCESS CARD" MEANS THE IDENTIFICATION CARD ISSUED BY THE U.S. DEPARTMENT OF DEFENSE TO ACTIVE-DUTY MILITARY PERSONNEL, ELIGIBLE RESERVE PERSONNEL, DEPARTMENT OF DEFENSE CIVILIAN EMPLOYEES, AND ELIGIBLE DEPARTMENT OF DEFENSE CONTRACTOR PERSONNEL.**

1           **(3) “FEDERAL POST CARD APPLICATION” MEANS THE FORM**  
2 **PRESCRIBED UNDER 52 U.S.C. § 20301(B)(2) THAT MAY BE USED BY ABSENT**  
3 **UNIFORMED SERVICES VOTERS AND OVERSEAS VOTERS TO SIMULTANEOUSLY**  
4 **APPLY TO REGISTER TO VOTE AND APPLY FOR AN ABSENTEE BALLOT.**

5           **(B) THE STATE BOARD SHALL ESTABLISH A PROCESS FOR AN INDIVIDUAL**  
6 **TO:**

7           **(1) SUBMIT THE FEDERAL POST CARD APPLICATION**  
8 **ELECTRONICALLY; AND**

9           **(2) USE A COMMON ACCESS CARD TO SIGN THE FEDERAL POST CARD**  
10 **APPLICATION.**

11           **(C) THE PROCESS REQUIRED TO BE ESTABLISHED UNDER SUBSECTION (B)**  
12 **OF THIS SECTION:**

13           **(1) MAY ALLOW THE USE OF A COMMON ACCESS CARD ONLY FOR THE**  
14 **PURPOSE OF VERIFYING IDENTITY AND ALLOWING AN INDIVIDUAL TO FULFILL THE**  
15 **SIGNATURE REQUIREMENT ON THE FEDERAL POST CARD APPLICATION; AND**

16           **(2) MAY NOT ALLOW AN INDIVIDUAL TO APPLY TO REGISTER TO VOTE**  
17 **SOLELY USING THE COMMON ACCESS CARD.**

19           (a) (1) The State Board shall designate public agencies and nongovernmental  
20 agencies as voter registration agencies where qualified individuals may apply to register to  
21 vote.

22           (2) The State Board shall designate the following offices as voter  
23 registration agencies:

24           (i) all offices in the State that provide public assistance;

25           (ii) all offices in the State that provide State–funded programs  
26 primarily engaged in providing services to individuals with disabilities;

27           (iii) all public institutions of higher education in the State; and

28           (iv) all one–stop career centers in the Maryland Department of  
29 Labor.

1           (3) The State Board and the Secretary of Defense shall jointly develop and  
2 implement procedures for persons to apply to register to vote at recruitment offices of the  
3 armed forces of the United States, which shall be deemed voter registration agencies.

4           (b) Except for a public institution of higher education in the State, which  
5 institution shall comply with the requirements of subsection (c) of this section **AND §**  
6 **3-204.2(F) OF THIS SUBTITLE**, each voter registration agency, as provided in subsection  
7 (a)(2) and (3) of this section, shall:

8           (1) distribute a voter registration application approved by the State Board  
9 or the Federal Election Commission with each application for service or assistance it  
10 renders and with each recertification, renewal, or change of address form relating to such  
11 service or assistance;

12           (2) provide a document to prospective registrants that includes:

13           (i) the question, “If you are not registered to vote where you live  
14 now, would you like to apply to register to vote here today?”;

15           (ii) if the agency provides public assistance, the statement,  
16 “Applying to register or declining to register to vote will not affect the amount of assistance  
17 that you will be provided by this agency.”;

18           (iii) boxes for the applicant to check to indicate whether the applicant  
19 would like to register or declines to register to vote together with the statement (in close  
20 proximity to the boxes and in prominent type), “If you do not check either box, you will be  
21 considered to have decided not to register to vote at this time.”;

22           (iv) the statement, “If you would like help in filling out the voter  
23 registration application form, we will help you. The decision whether to seek or accept help  
24 is yours. You may fill out the application form in private.”;

25           (v) the statement, “If you believe that someone has interfered with  
26 your right to register or to decline to register to vote, your right to privacy in deciding  
27 whether to register or in applying to register to vote, or your right to choose your own  
28 political party or other political preference, you may file a complaint with the State Board  
29 of Elections.”; and

30           (vi) the address and toll free telephone number of the State Board;

31           (3) provide each applicant who does not decline to register to vote and who  
32 accepts assistance the same degree of assistance with regard to completion of the  
33 registration application as is provided by the office with regard to the completion of its own  
34 applications, unless the applicant refuses such assistance;

35           (4) ensure that each application (4) for service or assistance from the agency  
36 and each recertification, renewal, or change of address form relating to the service or

1 assistance may not be completed until the applicant has indicated whether the applicant  
2 wishes to register to vote and is informed that if the applicant does not select a political  
3 party affiliation, the individual will be designated as not affiliated with a political party  
4 and will be unable to vote in a party primary election; and

5 (5) accept the completed voter registration application for transmittal to  
6 the appropriate election board.

7 [(c) (1) (i) In this subsection the following words have the meanings  
8 indicated.

9 (ii) "Commission" means the Maryland Higher Education  
10 Commission.

11 (iii) "Institution of higher education" has the meaning stated in §  
12 10–101(h) of the Education Article.

13 (2) (i) On or before July 1, 2017, a public institution of higher education  
14 shall provide a link to the online voter registration system on the home page of the online  
15 portal used by students to register for course work.

16 (ii) The link to the online voter registration system shall be  
17 prominently placed on the home page in a location where it may be easily viewed by  
18 students registering for course work.

19 (3) On or before January 1, 2019, and each year thereafter, a public  
20 institution of higher education shall submit a report to the Commission that describes:

21 (i) the number of students who are residents of the State and  
22 registered for course work in the preceding calendar year at the public institution of higher  
23 education and the number of those students who clicked on the link required under  
24 paragraph (2) of this subsection; and

25 (ii) any efforts the public institution of higher education plans to  
26 make to improve access to voter registration for students at the institution.

27 (4) On or before January 15, 2019, and each year thereafter, the  
28 Commission shall compile and summarize the information reported by public institutions  
29 of higher education under paragraph (3) of this subsection, in a single report and submit  
30 the report to the Senate Education, Health, and Environmental Affairs Committee and the  
31 House Committee on Ways and Means, in accordance with § 2–1257 of the State  
32 Government Article.]

4 **RECOGNIZED STUDENT ORGANIZATIONS, AND OTHER APPROPRIATE**  
5 **STAKEHOLDERS AT THE INSTITUTION.**

6           **(3) THE STUDENT VOTING PLAN SHALL:**

7                   **(I) COVER THE 2-YEAR PERIOD IMMEDIATELY PRECEDING**  
8 **EACH STATEWIDE GENERAL ELECTION; AND**

9                   **(II) BE UPDATED AFTER EACH STATEWIDE GENERAL ELECTION.**

21 REQUIRED UNDER PARAGRAPH (2) OF THIS SUBSECTION IN THE IMMEDIATELY  
22 PRECEDING CALENDAR YEAR, A DESCRIPTION OF ANY APPROPRIATE STEPS THE  
23 INSTITUTION IS TAKING TO ENCOURAGE STUDENTS TO USE THE LINK; AND

24                   3. ANY EFFORTS THE PRIVATE NONPROFIT INSTITUTION  
25 OF HIGHER EDUCATION PLANS TO MAKE TO IMPROVE ACCESS TO VOTER  
26 REGISTRATION FOR STUDENTS AT THE INSTITUTION.

27                   (ii) ON OR BEFORE JANUARY 15 EACH YEAR, THE ASSOCIATION  
28 SHALL COMPILE AND SUMMARIZE THE INFORMATION REPORTED BY ITS MEMBERS  
29 UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH IN A SINGLE REPORT AND SUBMIT  
30 THE REPORT TO THE SENATE EDUCATION, HEALTH, AND ENVIRONMENTAL  
31 AFFAIRS COMMITTEE AND THE HOUSE COMMITTEE ON WAYS AND MEANS IN
