3 **(The Dennis Robin Act)**

4 FOR the purpose of requiring an owner of a pharmacy to ~~post or mail a~~ provide certain
5 notice of a closing of the pharmacy within a certain period of time; requiring the
6 notice to include certain information; requiring the State Board of Pharmacy to adopt
7 certain regulations; and generally relating to the closing of a pharmacy.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Health Occupations**

16 **12-513.**

17 **(A) BEFORE THE CLOSING OF A PHARMACY FOR MORE THAN 7**
18 **CONSECUTIVE DAYS, THE OWNER OF THE PHARMACY SHALL PROVIDE NOTICE OF**
19 **THE CLOSING BY:**

4 ~~(H)~~ **1. THAT IS CONSPICUOUSLY POSITIONED IN THE**
 5 **PHARMACY AND READABLE BY PHARMACY CUSTOMERS; AND**

6 ~~(H)~~ **2. IF APPLICABLE, ON THE PHARMACY'S WEBSITE; AND**

7 **(II) PROVIDING WRITTEN AND VERBAL NOTICE TO EACH**
 8 **CUSTOMER WHO PICKS UP A PRESCRIPTION OR REFILL; OR**

9 **(2) AT LEAST 14 DAYS BEFORE THE ANTICIPATED CLOSING OF THE**
 10 **PHARMACY, MAILING A NOTICE TO EACH PHARMACY CUSTOMER THAT HAS A**
 11 **CURRENT AND AUTHORIZED REFILL OF A PRESCRIPTION ON FILE WITH THE**
 12 **PHARMACY.**

13 **(B) EACH NOTICE ~~POSTED OR MAILED IN ACCORDANCE WITH SUBSECTION~~**
 14 **~~(A) OF THIS SECTION~~ SHALL INDICATE:**

15 **(1) THE DATE OF THE ANTICIPATED CLOSING OF THE PHARMACY, IF**
 16 **AVAILABLE;**

17 **(2) THE NAME OF THE PHARMACY TO WHICH THE CLOSING**
 18 **PHARMACY WILL TRANSFER PHARMACY CUSTOMERS' PRESCRIPTIONS AND**
 19 **RECORDS; AND**

20 **(3) THAT A PHARMACY CUSTOMER MAY REQUEST THE CLOSING**
 21 **PHARMACY TO SEND THE PHARMACY CUSTOMER'S PRESCRIPTIONS AND RECORDS**
 22 **TO ANOTHER PHARMACY.**

23 **(C) THE BOARD SHALL ADOPT REGULATIONS TO:**

24 **(1) DEFINE "CLOSING OF A PHARMACY"; AND**

25 **(2) PROVIDE EXCEPTIONS TO THE REQUIREMENTS OF THIS SECTION.**

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 27 October 1, 2021.
