1 AN ACT concerning

2 **Human Services – Trauma-Informed Care – Commission and Training**
3 **(Healing Maryland’s Trauma Act)**

4 FOR the purpose of establishing the Commission on Trauma-Informed Care; providing for
5 the composition, chair, and staffing of the Commission; providing that the
6 Commission is an independent commission functioning in the Department of Human
7 Services; providing for the purpose of the Commission; requiring the Commission to
8 determine certain procedures; providing for the terms of members of the
9 Commission; requiring the Governor to designate the chair of the Commission;
10 prohibiting a member of the Commission from receiving certain compensation, but
11 authorizing the reimbursement of certain expenses; providing that a majority of
12 members serving on the Commission is a quorum; requiring the Commission to
13 identify certain programs and services; requiring the Commission to assist in the
14 development of a certain statewide trauma-responsive strategy; requiring the
15 Commission to establish certain metrics, in collaboration with the Maryland
16 Department of Health, related to a certain initiative; requiring the Commission to
17 coordinate and develop, in consultation with the Maryland Department of Health,
18 certain training on trauma-informed care; requiring the Commission to disseminate
19 certain information among agencies; requiring the Commission to advise and assist
20 the Governor for a certain purpose; requiring the Commission to report its findings
21 and recommendations to the Governor and the General Assembly on or before a
22 certain date each year; requiring the Commission, in consultation with the Maryland
23 Department of Health, the Department of Human Services, and the Maryland

Health Care Commission, to conduct a certain study of a certain program and implement a certain program; providing for the purpose of a certain program; specifying the content of a certain study; requiring the Commission to report certain findings and recommendations to the Governor and the General Assembly on or before a certain date each year; requiring members of the Commission to participate in a certain training each year; requiring certain State agencies to designate certain staff members to participate in a certain training each year; requiring certain staff members of certain State agencies to perform certain duties in a certain manner each year; requiring the Maryland Department of Health to provide certain technical support to certain staff members of certain State agencies; requiring certain directors of certain State agencies to submit to the Commission a certain report each year; defining certain terms; and generally relating to trauma-informed care.

19 YEARS CONCURRENT WITH THE TERM OF THE GOVERNOR'S TERM OF OFFICE.

20 (2) A MEMBER WHO IS APPOINTED AFTER THE TERM HAS BEGUN
21 SERVES ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED
22 AND QUALIFIES.

23 (3) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL
24 A SUCCESSOR IS APPOINTED AND QUALIFIES.

28 CHILDHOOD EXPERIENCES AND TOXIC STRESS TO PROVIDE TARGETED
29 EVIDENCE-BASED INTERVENTIONS TO SUPPORT INDIVIDUAL AND FAMILY HEALTH,
30 IN ORDER TO IMPROVE INDIVIDUAL AND FAMILY WELL-BEING AND REDUCE HEALTH
31 CARE COSTS.

32 (4) AS PART OF THE STUDY, THE COMMISSION SHALL:

1 **(I) PROPOSE A PROCESS TO SET UP TRAINING AND AN**
2 **ACCREDITATION PROCESS FOR PROVIDERS IN THE PROGRAM; AND**

3 **(II) EXPLORE THE POSSIBILITY OF THIRD-PARTY**
4 **REIMBURSEMENT, INCLUDING THE STATE MEDICAL ASSISTANCE PROGRAM, FOR**
5 **SCREENINGS UNDER THE PROGRAM.**

6 **(5) ON OR BEFORE OCTOBER 1 EACH YEAR, BEGINNING IN 2022, THE**
7 **COMMISSION SHALL REPORT ITS FINDINGS AND RECOMMENDATIONS REGARDING**
8 **THE DEVELOPMENT AND IMPLEMENTATION OF THE PROGRAM TO THE GOVERNOR**

17 **DESIGNEE IN COLLABORATION WITH THE COMMISSION.**

18 **(B) EACH COMMISSION MEMBER SHALL PARTICIPATE IN AT LEAST ONE**
19 **FORMAL TRAINING EACH YEAR.**

20 **(C) (1) EACH AGENCY HEAD SHALL DESIGNATE TWO STAFF MEMBERS TO:**

21 **(I) PARTICIPATE IN AT LEAST ONE FORMAL TRAINING EACH**
22 **YEAR;**

23 **(II) COLLABORATE WITH OTHER AGENCY DESIGNEES IN WORK**
24 **SESSIONS AND OTHER INFORMAL TRAININGS AS ORGANIZED BY THE MARYLAND**
25 **DEPARTMENT OF HEALTH;**

26 **(III) SERVE AS THE PRINCIPAL ADVISORS TO THE AGENCY**
27 **DIRECTOR AND AGENCY STAFF IN TRAUMA-RESPONSIVENESS AND**
28 **TRAUMA-INFORMED CARE;**

29 **(IV) ASSESS THE AGENCY FOR TRAINING AND TECHNICAL**
30 **ASSISTANCE NEEDS RELATED TO TRAUMA-RESPONSIVENESS AND**
31 **TRAUMA-INFORMED CARE; AND**

1 **(V) REVIEW AND MAKE APPROPRIATE RECOMMENDATIONS TO**
2 **THE AGENCY DIRECTOR TO ALIGN AGENCY POLICIES AND PRACTICES WITH A**
3 **TRAUMA-INFORMED APPROACH.**

4 **(2) IN THE EVENT OF A VACANCY IN THE POSITION OF ONE OR BOTH**
5 **OF THE STAFF MEMBERS DESIGNATED UNDER PARAGRAPH (1) OF THIS SUBSECTION,**
6 **THE AGENCY DIRECTOR SHALL, WITHIN 30 DAYS OF THE VACANCY, DESIGNATE**
7 **ANOTHER STAFF MEMBER TO CARRY OUT THE DUTIES OF THE STAFF MEMBER**
8 **DESCRIBED IN PARAGRAPH (1) OF THIS SUBSECTION.**

9 **(D) THE MARYLAND DEPARTMENT OF HEALTH SHALL PROVIDE**
10 **TECHNICAL ADVISORY SUPPORT TO DESIGNATED AGENCY STAFF TO ASSIST THE**
11 **STAFF IN PERFORMING THE DUTIES DESCRIBED IN SUBSECTION (C)(1) OF THIS**
12 **SECTION.**

13 **(E) ON OR BEFORE MARCH 31 EACH YEAR, EACH AGENCY DIRECTOR SHALL**
14 **SUBMIT TO THE COMMISSION A PROGRESS REPORT DETAILING THE AGENCY'S**
15 **PROGRESS AND COMPLIANCE WITH SUBSECTION (C) OF THIS SECTION.**

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
17 1, 2021.
