### Agriculture – Neonicotinoid Pesticides – Sale and Storage

- FOR the purpose of restricting a person that sells a neonicotinoid pesticide under certain provisions of law to selling a neonicotinoid pesticide only to a certain certified applicator or farmer; requiring a person selling a neonicotinoid pesticide to store a neonicotinoid pesticide in a certain manner; making stylistic and conforming changes; defining certain terms; and generally relating to neonicotinoid pesticides.

# (c) "Certified applicator" means a person who is certified by the Secretary under this subtitle.

1 (r) "Restricted use pesticide" means a pesticide so classified by the provisions in 2 this title or by the federal government or the Secretary of Agriculture, State of Maryland.

4 (A) In this subtitle[, "neonicotinoid] THE FOLLOWING WORDS HAVE THE 5 MEANINGS INDICATED.

6 (B) "CERTIFIED APPLICATOR" HAS THE MEANING STATED IN § 5–201 OF 7 THIS TITLE.

8 (C) "NEONICOTINOID pesticide" means any pesticide containing a chemical 9 belonging to the neonicotinoid class of chemicals, including:

- 10 (1) Imidacloprid;
- 11 (2) Nithiazine;
- 12 (3) Acetamiprid;
- 13 (4) Clothianidin;
- 14 (5) Dinotefuran;
- 15 (6) Thiacloprid;
- 16 (7) Thiamethoxam; and

17 (8) Any other chemical designated by the Department as belonging to the 18 neonicotinoid class of chemicals.

19 (D) "RESTRICTED USE PESTICIDE" HAS THE MEANING STATED IN § 5–201 OF 20 THIS TITLE.

22 (a) [(1)] This section does not apply to:

23 [(i)] (1) Pet care products used to mitigate fleas, mites, ticks, 24 heartworms, or other animals that are harmful to the health of a domesticated animal;

25[(ii)] (2)Personal care products used to mitigate lice and bedbugs;26and

1 [(iii)] (3) Indoor pest control products used to mitigate insects 2 indoors, including ant bait.

3 [(2)] (B) (1) On or after January 1, 2018, a person may not sell at retail 4 in the State a neonicotinoid pesticide unless the person also sells a restricted use pesticide [, 5 as defined in § 5–201 of this title].

6 (2) A PERSON THAT SELLS A NEONICOTINOID PESTICIDE UNDER 7 PARAGRAPH (1) OF THIS SUBSECTION:

8 (I) MAY SELL A NEONICOTINOID PESTICIDE ONLY TO A 9 CERTIFIED APPLICATOR OR A FARMER; AND

(II) SHALL STORE EACH NEONICOTINOID PESTICIDE BEHIND
THE COUNTER AND IN A MANNER THAT IS INACCESSIBLE TO A CUSTOMER WITHOUT
THE ASSISTANCE FROM THE PERSON OR AN EMPLOYEE OF THE PERSON.

13 [(b)] (C) On or after January 1, 2018, a person may not use a neonicotinoid 14 pesticide unless the person is:

15 (1) A certified applicator or a person working under the supervision of a 16 certified applicator [, as defined in § 5–201 of this title];

17 (2) A farmer, or a person under the supervision of a farmer, who uses the 18 pesticide for agricultural purposes, including crop production, livestock, poultry, equine, 19 and noncrop agricultural fields; or

20 (3) A veterinarian.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 22 October 1, 2021.
