Cancer Drugs - Physician Dispensing and Coverage

3 FOR the purpose of providing that certain provisions of law do not prohibit a physician who 4 has a valid dispensing permit and complies with certain provisions of law from personally dispensing to a patient by mail or other commercial method a starter 5 6 dosage of a cancer drug or device or an initial or refill prescription of a cancer drug; 7 requiring certain entities to allow certain insureds, enrollees, and beneficiaries to 8 obtain a cancer drug from a dispensing physician; defining certain terms; requiring 9 that certain beneficiaries be allowed to obtain a cancer drug from a dispensing 10 physician; providing for the application of this Act; providing for a delayed effective date; and generally relating to cancer drugs. 11

- [(a)] (B) Except as provided in subsection [(b)] (C) of this section, a pharmacy benefits manager may not require that a beneficiary use a specific pharmacy or entity to fill a prescription if:

- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect January 1, 2022.
