FOR the purpose of requiring the State Department of Education, in coordination with the 4 $\mathbf{5}$ Maryland Department of Health, to establish procedures for the administration of 6 certain Centers for Disease Control and Prevention surveys to certain students; 7 repealing the authority of the State Department of Education to omit a certain 8 amount of survey questions under certain circumstances; requiring that certain 9 actions taken by the State Department of Education be taken in coordination with the Maryland Department of Health; requiring the State Department of Education. 10 11 in coordination with the Maryland Department of Health, to include in the survey 12 certain tiers and at least a certain number of certain questions; requiring, within a certain period of time, the Maryland Department of Health to publish a certain data 1314 summary and trends report on certain data requiring that a certain report submitted 15by the Maryland Department of Health to the Governor and the General Assembly by a certain date in certain years include, beginning in a certain year, a certain data 16 summary and trends report on certain data; requiring the Maryland Department of 1718 Health to publish a certain data summary and trends report on certain data on or 19before a certain date; defining a certain term; making a technical change; and 20generally relating to Centers for Disease Control and Prevention surveys.

questions that will be administered and more information regarding the survey, including
the mailing address, telephone number, and website address of the Centers for Disease
Control and Prevention; and

(ii) Subject to subsection (d) of this section, a denial of permissionform that may be returned by the parent to the school.

13 (d) (1) For the academic year during which the survey will be conducted, the 14 denial of permission form shall be a part of the request for emergency contact information 15 that is distributed by the public school to each student or parent or guardian of the student.

16 (2) The denial of permission form shall be distributed only to a student or 17 the parent or guardian of a student who may be subject to the survey administered under 18 this section.

(a) Beginning in fiscal year 2007 and in every second year thereafter, the
 Department shall conduct a Tobacco Study which shall measure the same factors that are
 set forth in § 13–1003(c) of this subtitle and use the same methodology or model that was
 used for the Baseline Tobacco Study.

30 (b) To carry out the evaluation and surveillance functions of this subtitle, the 31 Department may conduct any other tobacco study measuring the factors set forth in § 32 13–1003(c) of this subtitle and using a methodology or model that is consistent with but 33 need not be identical to that used to conduct the Baseline Tobacco Study.
