3 FOR the purpose of prohibiting a person from committing a certain prohibited act with the 4 intent to interrupt or impair the functioning of a certain health care facility or a $\mathbf{5}$ certain public school; prohibiting a person from knowingly possessing certain 6 ransomware with the intent to use the ransomware for a certain purpose; creating a 7 certain exception; altering and establishing certain penalties; authorizing a victim 8 of a certain offense to bring a civil action for damages against a certain person; 9 providing for the recovery of certain attorney's fees and court costs in an action brought under this Act; establishing that a certain criminal conviction is not a 10 11 prerequisite for maintenance of an action under this Act; providing for the 12application of this Act; defining a certain term; and generally relating to crimes involving computers. 13

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
