A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County – Barbershop and Beauty Salon Beer and Wine Licenses –**
3 **Alterations**

4 FOR the purpose of altering a certain limitation on the amount of beer that a holder of a
5 barbershop or beauty salon beer and wine license in Frederick County may provide
6 to a certain customer for on–premises consumption; and generally relating to
7 alcoholic beverages licenses in Frederick County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages**

21 20–102.

22 This title applies only in Frederick County.

23 20–1001.3.

1 (a) There is a barbershop beer and wine license.

2 (b) The Board may issue the license to a holder of a barbershop permit under §
3 4–501 of the Business Occupations and Professions Article.

4 (c) The license authorizes the license holder to provide no more than 5 ounces of
5 [beer or] wine by the glass **OR 12 OUNCES OF BEER** for on–premises consumption by a
6 barbershop customer:

7 (1) when the customer is provided a service described in § 4–101(l) of the
8 Business Occupations and Professions Article; or

9 (2) while the customer is attending a fund–raising event at the barbershop
10 for which the Department of Permits and Inspections, if required, has issued a permit.

11 (d) The license may not be transferred to another location.

12 (e) The license holder may provide beer and wine for on–premises consumption
13 during normal business hours but not later than 9 p.m.

14 (f) The establishment for which a barbershop license is issued is subject to the
15 alcohol awareness training requirements under § 4–505 of this article, subject to § 20–1903
16 of this title.

17 (g) The annual license fee is \$100.

18 20–1002.

19 (a) There is a beauty salon beer and wine license.

20 (b) The Board may issue the license to a holder of a beauty salon permit under §
21 5–501 of the Business Occupations and Professions Article.

22 (c) The license authorizes the license holder to provide no more than 5 ounces of
23 [beer or] wine by the glass **OR 12 OUNCES OF BEER** for on–premises consumption by a
24 beauty salon customer:

25 (1) when the customer is provided a cosmetology service described in §
26 5–101(n)(1) of the Business Occupations and Professions Article; or

27 (2) while the customer is attending a fund–raising event at the beauty
28 salon for which the Department of Permits and Inspections, if required, has issued a permit.

29 (d) The license may not be transferred to another location.

30 (e) The license holder may provide beer and wine for on–premises consumption
31 during normal business hours but not later than 9 p.m.

1 (f) The establishment for which a beauty salon license is issued is subject to the
2 alcohol awareness training requirements under § 4–505 of this article, subject to § 20–1903
3 of this title.

4 (g) The annual license fee is \$100.

5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
6 1, 2021.
