CHAPTER _____

1 AN ACT concerning

2 **Growing Family Child Care Opportunities Pilot Program – Established**

3 FOR the purpose of establishing the Growing Family Child Care Opportunities Pilot
4 Program in the State Department of Education; stating the purpose of the Program;
5 requiring the Department to administer the Program in partnership with a certain
6 entity; requiring the Department to award certain grants to certain recipients;
7 requiring grant recipients to use the grants for certain purposes; requiring grant
8 recipients to raise certain funding, collaborate with certain providers during a
9 certain period, provide certain services, and establish certain partnerships for
10 certain purposes; requiring the Governor, subject to a certain provision of law, in
11 certain fiscal years, to include in the annual budget bill a certain appropriation for
12 the Program; requiring the Department to develop certain guidelines in partnership
13 with a certain entity; authorizing the Department to seek funding for the Program
14 and to provide grants as soon as possible under a certain circumstance; requiring the
15 Department to develop and publish goals for the Program each year; requiring the
16 Department to submit a certain report to the General Assembly on or before a certain
17 date of each year; defining certain terms; providing for the termination of this Act;
18 and generally relating to the Growing Family Child Care Opportunities Pilot
19 Program.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Education**

4 **9.5–113.**

5 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
6 INDICATED.

7 (2) “CHILD CARE LICENSING REGION” MEANS ANY ONE OF 13
8 REGIONS DESIGNATED BY THE DEPARTMENT TO PROVIDE LICENSING AND
9 OVERSIGHT FOR FAMILY CHILD CARE PROGRAMS.

10 (3) “FAMILY CHILD CARE” MEANS THE CARE GIVEN TO A CHILD
11 UNDER THE AGE OF 13 YEARS OR TO A DEVELOPMENTALLY DISABLED PERSON
12 UNDER THE AGE OF 21 YEARS THAT IS IN PLACE OF PARENTAL CARE FOR LESS THAN
13 24 HOURS A DAY, IN A RESIDENCE OTHER THAN THE CHILD’S RESIDENCE, FOR
14 WHICH THE FAMILY CHILD CARE PROVIDER IS PAID.

15 (4) “FAMILY CHILD CARE PROVIDER” MEANS AN INDIVIDUAL WHO
16 CARES FOR CHILDREN IN A REGISTERED FAMILY CHILD CARE HOME OR A
17 REGISTERED LARGE FAMILY CHILD CARE HOME.

18 (5) “LOCAL PILOT PROGRAM” MEANS A LOCAL JURISDICTION OR
19 CHILD CARE LICENSING REGION THAT PARTICIPATES IN THE PROGRAM.

20 (6) “PROGRAM” MEANS THE GROWING FAMILY CHILD CARE
21 OPPORTUNITIES PILOT PROGRAM.

22 (7) “START-UP ASSISTANCE” MEANS THE FUNDING FOR STARTING A
23 FAMILY CHILD CARE PROGRAM INCLUDING THE COST OF MATERIALS, CURRICULUM,
24 AND RENOVATIONS.

25 (B) (1) THERE IS A GROWING FAMILY CHILD CARE OPPORTUNITIES
26 PILOT PROGRAM IN THE DEPARTMENT.

27 (2) THE PURPOSE OF THE PROGRAM IS TO PROVIDE GRANTS TO
28 ESTABLISH AND SUPPORT LOCAL PILOT PROGRAMS IN THE STATE.

29 (3) THE DEPARTMENT SHALL PARTNER WITH THE MARYLAND CHILD
30 CARE RESOURCE NETWORK TO ADMINISTER THE PROGRAM.

1 (C) (1) EXCEPT AS PROVIDED IN SUBSECTION (G) OF THIS SECTION, ON
2 OR BEFORE SEPTEMBER 1, 2022, THE DEPARTMENT SHALL AWARD AT LEAST THREE
3 GRANTS, EACH OF WHICH DOES NOT EXCEED \$150,000 ~~GRANTS TO LOCAL~~
4 ~~JURISDICTIONS OR CHILD CARE LICENSING REGIONS,~~ IN ACCORDANCE WITH
5 PARAGRAPH (2) OF THIS SUBSECTION TO ESTABLISH AND SUPPORT FAMILY CHILD
6 CARE PROVIDERS IN THE STATE.

7 (2) ~~GRANTS SHALL BE AWARDED WITHIN EACH OF THE FOLLOWING~~
8 ~~AREAS:~~

9 (I) ~~URBAN;~~

10 (II) ~~SUBURBAN; AND~~

11 (III) ~~A CHILD CARE LICENSING REGION LOCATED IN A RURAL~~
12 ~~AREA~~

13 (I) TO BE ELIGIBLE FOR A GRANT UNDER THIS SECTION, A
14 COUNTY GOVERNING BODY OR MULTIPLE COUNTY GOVERNING BODIES SHALL SIGN
15 A MEMORANDUM OF UNDERSTANDING WITH A CHILD CARE RESOURCE CENTER THAT
16 SERVES THE CHILD CARE LICENSING REGION THAT CONTAINS ONE OF THE
17 COUNTIES.

18 (II) THE COUNTY OR COUNTIES AND THE CHILD CARE
19 RESOURCE CENTER JOINTLY SHALL APPLY FOR THE GRANT AND ADMINISTER THE
20 LOCAL PILOT PROGRAM.

21 (D) GRANT RECIPIENTS SHALL:

22 (1) USE THE GRANTS TO:

23 (I) ESTABLISH AND SUPPORT A LOCAL PILOT PROGRAM; AND

24 (II) TARGET THE USE OF THE GRANT TO INCREASE THE SUPPLY
25 AND ENSURE THE SUSTAINABILITY OF FAMILY CHILD CARE PROVIDERS IN AREAS
26 WITH ABOVE AVERAGE RATES OF POVERTY AND UNEMPLOYMENT OR AREAS WITH A
27 LACK OF AVAILABLE CHILD CARE PROVIDERS;

28 (2) RAISE LOCAL MATCHING FUNDS, INCLUDING IN-KIND MATCHING
29 RESOURCES AT A 1:1 MATCH;

30 (3) COLLABORATE WITH EXISTING FAMILY CHILD CARE PROVIDERS
31 DURING THE IMPLEMENTATION OF THE PROGRAM;

1 **(4) PROVIDE MULTILINGUAL OUTREACH TO RECRUIT INDIVIDUALS**
2 **TO BECOME REGISTERED FAMILY CHILD CARE PROVIDERS WITH THE DEPARTMENT;**

3 **(5) PROVIDE TECHNICAL ASSISTANCE, FINANCIAL INCENTIVES, AND**
4 **START-UP ASSISTANCE FOR RECRUITED INDIVIDUALS AS THEY NAVIGATE THE**
5 **DEPARTMENT'S PROCESS TO BECOME A REGISTERED FAMILY CHILD CARE**
6 **PROVIDER;**

7 **(6) ASSIST NEWLY REGISTERED AND ESTABLISHED FAMILY CHILD**
8 **CARE PROVIDERS THROUGH TECHNICAL ASSISTANCE TO ACHIEVE QUALITY**
9 **BENCHMARKS, PEER-TO-PEER MENTORING, AND FINANCIAL INCENTIVES; AND**

10 **(7) ESTABLISH PARTNERSHIPS WITH LOCAL CHAMBERS OF**
11 **COMMERCE, OR OTHER LOCAL OR STATE ORGANIZATIONS FOR FAMILY CHILD CARE**
12 **PROVIDERS THAT SUPPORT SMALL BUSINESSES AND WOMEN AND**
13 **MINORITY-OWNED BUSINESSES TO PROVIDE:**

14 **(I) ASSISTANCE TO RECRUITED INDIVIDUALS OR REGISTERED**
15 **FAMILY CHILD CARE PROVIDERS IN IMPLEMENTING BEST BUSINESS PRACTICES;**
16 **AND**

17 **(II) ASSISTANCE IN ACHIEVING FINANCIAL SUSTAINABILITY.**

18 **(E) (1) ~~FOR~~ SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, FOR**
19 **EACH OF FISCAL YEARS 2023 AND 2024, THE GOVERNOR SHALL INCLUDE IN THE**
20 **ANNUAL BUDGET BILL AN APPROPRIATION OF \$450,000 TO THE PROGRAM.**

21 **(2) TO THE EXTENT AUTHORIZED UNDER FEDERAL LAW, THE**
22 **GOVERNOR SHALL USE FEDERAL FUNDS TO SATISFY THE REQUIREMENT OF**
23 **PARAGRAPH (1) OF THIS SUBSECTION.**

24 **(F) THE DEPARTMENT SHALL DEVELOP GUIDELINES, IN CONSULTATION**
25 **WITH THE MARYLAND CHILD CARE RESOURCE CENTER, FOR THE GRANT**
26 **APPLICATION PROCESS AND GRANT RECIPIENTS.**

27 **(G) (1) THE DEPARTMENT MAY SEEK FUNDING TO START THE PROGRAM.**

28 **(2) IF THE DEPARTMENT RECEIVES FUNDING BEFORE JULY 1, 2022,**
29 **THE DEPARTMENT SHALL BEGIN AWARDING GRANTS AS SOON AS POSSIBLE UNDER**
30 **THE PROGRAM.**

31 **(H) EACH YEAR, THE DEPARTMENT SHALL DEVELOP AND PUBLISH GOALS**
32 **FOR THE PROGRAM.**

1 **(I) ON OR BEFORE DECEMBER 1, 2021, AND EACH DECEMBER 1**
2 **THEREAFTER, THE DEPARTMENT SHALL REPORT TO THE GENERAL ASSEMBLY, IN**
3 **ACCORDANCE WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE, ON THE**
4 **STATUS OF THE PROGRAM AND AN EVALUATION OF LOCAL PILOT PROGRAMS IN**
5 **MEETING THE PROGRAM GOALS.**

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
7 1, 2021. It shall remain effective for a period of 4 years and, at the end of June 30, 2025,
8 this Act, with no further action required by the General Assembly, shall be abrogated and
9 of no further force and effect.
