1 AN ACT concerning

2 **Higher Education – Hunger-Free Campus Grant Program – Established**

3 FOR the purpose of establishing the Hunger-Free Campus Grant Program; stating the
4 purposes of the Program; requiring the Maryland Higher Education Commission to
5 administer the Program, develop a certain form, and designate certain campuses at
6 certain public institutions of higher education or regional higher education centers
7 as hunger-free campuses using certain criteria; authorizing certain public
8 institutions of higher education to develop certain procedures; requiring certain
9 public institutions of higher education to make certain information publicly
10 available; requiring the Governor, beginning in a certain fiscal year, to include in the
11 annual budget bill a certain appropriation for the Program; requiring the
12 Commission to allocate grant funding to certain public institutions of higher
13 education or regional higher education centers; requiring the Commission to
14 determine the amount of grant funding to each eligible public institution of higher

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 14 That the Laws of Maryland read as follows:

16 **SUBTITLE 17. HUNGER-FREE CAMPUS GRANT PROGRAM.**

18 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS
 19 INDICATED.

20 (B) “EMERGENCY ASSISTANCE” MEANS IMMEDIATE DIRECT ASSISTANCE
 21 PROVIDED BY A HUNGER-FREE CAMPUS TO ANY STUDENT FACING AN
 22 UNANTICIPATED FINANCIAL CRISIS OR HARDSHIP.

23 (C) “HUNGER-FREE CAMPUS” MEANS A CAMPUS OF ANY 4-YEAR PUBLIC
 24 INSTITUTION OF HIGHER EDUCATION *OR REGIONAL HIGHER EDUCATION CENTER*
 25 THAT MEETS THE REQUIREMENTS OF § 11–1703(A) OF THIS SUBTITLE OR ANY
 26 2-YEAR PUBLIC INSTITUTION OF HIGHER EDUCATION THAT MEETS THE
 27 REQUIREMENTS OF § 11–1703(B) OF THIS SUBTITLE.

28 (D) “PROGRAM” MEANS THE HUNGER-FREE CAMPUS GRANT PROGRAM.

30 (A) THERE IS A HUNGER-FREE CAMPUS GRANT PROGRAM.

31 (B) THE PURPOSE OF THE PROGRAM IS TO:

32 (1) ADDRESS STUDENT HUNGER;

1 **(2) LEVERAGE MORE SUSTAINABLE SOLUTIONS TO ADDRESS BASIC**
2 **FOOD NEEDS ON CAMPUS;**

3 **(3) RAISE AWARENESS OF SERVICES CURRENTLY OFFERED ON**
4 **CAMPUS THAT ADDRESS BASIC FOOD NEEDS; AND**

5 **(4) BUILD STRATEGIC PARTNERSHIPS AT THE LOCAL, STATE, AND**
6 **NATIONAL LEVELS TO ADDRESS FOOD INSECURITY AMONG STUDENTS.**

7 **(c) (1) THE COMMISSION SHALL ADMINISTER THE PROGRAM.**

8 **(2) THE COMMISSION SHALL DEVELOP THE FORM TO BE USED FOR**
9 **THE ANNUAL STUDENT SURVEY REQUIRED UNDER § 11-1703 OF THIS SUBTITLE.**

10 **11-1703.**

11 **(A) THE COMMISSION SHALL DESIGNATE AS A HUNGER-FREE CAMPUS ANY**
12 **CAMPUS OF A 4-YEAR PUBLIC INSTITUTION OF HIGHER EDUCATION OR REGIONAL**
13 **HIGHER EDUCATION CENTER THAT:**

14 **(1) HAS ESTABLISHED A HUNGER TASK FORCE THAT:**

15 **(i) MEETS AT LEAST THREE TIMES PER ACADEMIC YEAR; AND**

16 **(ii) SETS AT LEAST TWO GOALS WITH ACTION PLANS;**

17 **(2) HAS DESIGNATED A STAFF MEMBER RESPONSIBLE FOR:**

18 **(i) ASSISTING STUDENTS IN ENROLLING IN THE**
19 **SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM; OR**

20 **(ii) CONNECTING STUDENTS WITH AVAILABLE SUPPLEMENTAL**
21 **NUTRITION ASSISTANCE PROGRAM OUTREACH PARTNERS THAT CAN ASSIST**
22 **STUDENTS IN ENROLLING IN THE SUPPLEMENTAL NUTRITION ASSISTANCE**
23 **PROGRAM;**

24 **(3) HAS DESIGNATED A STAFF MEMBER RESPONSIBLE FOR**
25 **INFORMING STUDENTS PARTICIPATING IN FEDERAL WORK-STUDY PROGRAMS THAT**
26 **THEY ARE ELIGIBLE FOR THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM;**

27 **(4) (i) PROVIDES OPTIONS FOR STUDENTS TO UTILIZE**
28 **SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM BENEFITS AT CAMPUS**
29 **RETAILERS; OR**

1 (II) PROVIDES STUDENTS WITH INFORMATION ON THE NAMES
2 AND LOCATIONS OF OFF-CAMPUS RETAILERS THAT ACCEPT SUPPLEMENTAL
3 NUTRITION ASSISTANCE PROGRAM BENEFITS;

4 (5) PARTICIPATES IN AN AWARENESS DAY CAMPAIGN ACTIVITY AND
5 PLANS AT LEAST ONE CAMPUS AWARENESS EVENT DURING THE NATIONAL HUNGER
6 AND HOMELESSNESS AWARENESS WEEK;

7 (6) PROVIDES AT LEAST ONE FOOD PANTRY ON CAMPUS, OR ENABLES
8 STUDENTS IN NEED TO RECEIVE FOOD THROUGH A SEPARATE, STIGMA-FREE
9 ARRANGEMENT;

10 (7) DEVELOPS AND MAINTAINS A MEAL-SHARING PROGRAM THAT
11 ALLOWS STUDENTS TO DONATE THEIR UNUSED MEAL PLAN CREDITS TO BE
12 DISTRIBUTED TO STUDENTS IN NEED FOR USE IN CAMPUS DINING HALLS OR AT AN
13 ON-CAMPUS FOOD PANTRY, IF APPLICABLE;

14 (8) CONDUCTS A STANDARDIZED ANNUAL STUDENT SURVEY ON
15 HUNGER AND SUBMITS THE RESULTS TO THE COMMISSION; AND

16 (9) SUBMITS AN ANNUAL REPORT DETAILING ITS EFFORTS TO
17 ADDRESS STUDENT HUNGER TO THE COMMISSION.

18 (B) THE COMMISSION SHALL DESIGNATE AS A HUNGER-FREE CAMPUS ANY
19 CAMPUS OF A 2-YEAR PUBLIC INSTITUTION OF HIGHER EDUCATION THAT MEETS
20 ALL OF THE REQUIREMENTS FOR 4-YEAR PUBLIC INSTITUTIONS OF HIGHER
21 EDUCATION OR REGIONAL HIGHER EDUCATION CENTERS IDENTIFIED IN
22 SUBSECTION (A) OF THIS SECTION, WITH THE EXCEPTION OF THE REQUIREMENTS IN
23 SUBSECTION (A)(4) AND (7) OF THIS SECTION.

24 (C) (1) EACH 4-YEAR PUBLIC INSTITUTION OF HIGHER EDUCATION MAY
25 DEVELOP ITS OWN PROCEDURES FOR A MEAL-SHARING PROGRAM.

26 (2) THE 4-YEAR PUBLIC INSTITUTIONS OF HIGHER EDUCATION
27 SHALL MAKE INFORMATION ABOUT THE MEAL-SHARING PROGRAM PUBLICLY
28 AVAILABLE, INCLUDING:

29 (I) HOW A STUDENT MAY DONATE UNUSED MEAL PLAN
30 CREDITS;

31 (II) HOW A STUDENT IN NEED MAY APPLY TO RECEIVE DONATED
32 MEAL PLAN CREDITS; AND

1 (III) THE METHODOLOGY THAT A 4-YEAR PUBLIC INSTITUTION
2 OF HIGHER EDUCATION USES TO ENSURE THAT UNUSED DONATED MEAL PLAN
3 CREDITS ARE USED TO PURCHASE FOOD TO SUPPORT AN ON-CAMPUS FOOD PANTRY,
4 IF APPLICABLE.

6 FOR FISCAL YEAR 2023 AND EACH FISCAL YEAR THEREAFTER, THE
7 GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF
8 \$150,000 FOR THE PROGRAM.

9 11-1705.

10 (A) THE COMMISSION SHALL ALLOCATE GRANT FUNDING TO ANY
11 4-YEAR OR 2-YEAR PUBLIC INSTITUTION OF HIGHER EDUCATION OR REGIONAL
12 HIGHER EDUCATION CENTER THAT:

13 (1) PLEDGES A MATCHING CONTRIBUTION TO BE USED TO
14 IMPLEMENT THE GOALS OF THE PROGRAM; AND

15 (2) IS DESIGNATED AS A HUNGER-FREE CAMPUS.

16 (B) THE COMMISSION SHALL DETERMINE THE AMOUNT OF EACH GRANT.

17 (C) THE COMMISSION SHALL INCORPORATE INTO THE 2026-2030 STATE
18 PLAN FOR HIGHER EDUCATION A PLAN FOR ADDRESSING ANY BASIC NEEDS
19 INSECURITY OF HIGHER EDUCATION STUDENTS.

20 (D) (1) THE COMMISSION SHALL ADOPT REGULATIONS NECESSARY TO
21 CARRY OUT THE REQUIREMENTS OF THIS SUBTITLE.

22 (2) THE REGULATIONS ADOPTED UNDER THIS SUBSECTION SHALL
23 ALLOW GRANT RECIPIENTS TO USE GRANT FUNDS FLEXIBLY TO IMPLEMENT THE
24 GOALS OF THE PROGRAM, INCLUDING GIVING RECIPIENTS THE ABILITY TO:

25 (I) SUPPORT EMERGENCY ASSISTANCE;

26 (II) HIRE STAFF TO MANAGE INITIATIVES RELATED TO THE
27 PROGRAM; AND

28 (III) USE GRANT FUNDS FOR OPERATIONAL ACTIVITIES
29 RELATED TO THE PROGRAM.

30 11-1706.

1 (A) NOT LATER THAN 2 YEARS AFTER ESTABLISHING THE PROGRAM, THE
2 COMMISSION SHALL REPORT TO THE GOVERNOR AND, IN ACCORDANCE WITH §
3 2-1257 OF THE STATE GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY ON THE
4 IMPLEMENTATION OF THIS SUBTITLE.

5 (B) THE REPORT SHALL INCLUDE:

6 (1) THE NUMBER AND AMOUNTS OF GRANTS AWARDED;

7 (2) THE IMPACT OF THE PROGRAM ON ESTABLISHING HUNGER-FREE
8 CAMPUSES AT PUBLIC INSTITUTIONS OF HIGHER EDUCATION AND REGIONAL
9 HIGHER EDUCATION CENTERS;

10 (3) THE IMPACT OF AWARDED GRANTS ON REDUCING THE NUMBER
11 OF STUDENTS EXPERIENCING FOOD INSECURITY; AND

12 (4) RECOMMENDATIONS ON EXPANDING THE PROGRAM.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
14 October 1, 2021.
