Higher Education - Hunger-Free Campus Grant Program - Established

FOR the purpose of establishing the Hunger-Free Campus Grant Program; stating the purposes of the Program; requiring the Maryland Higher Education Commission to administer the Program, develop a certain form, and designate certain campuses at certain public institutions of higher education or regional higher education centers as hunger-free campuses using certain criteria; authorizing certain public institutions of higher education to develop certain procedures; requiring certain public institutions of higher education to make certain information publicly available; requiring the Governor, beginning in a certain fiscal year, to include in the annual budget bill a certain appropriation for the Program; requiring the Commission to allocate grant funding to certain public institutions of higher education or regional higher education centers; requiring the Commission to determine the amount of grant funding to each eligible public institution of higher
