Economic Development – Western Maryland Economic Future Investment Board and Fund – Establishment

FOR the purpose of establishing the Western Maryland Economic Future Investment Board: providing for the composition, chair, and staffing of the Board: prohibiting a member of the Board from receiving certain compensation, but authorizing the reimbursement of certain expenses; establishing the Western Maryland Economic Future Investment Fund as a special, nonlapsing fund; specifying the purpose of the Fund; requiring the Tri-County Council for Western Maryland to administer the Fund; requiring the State Treasurer to hold the Fund and the Comptroller to account for the Fund; specifying the contents of the Fund; specifying the purpose for which the Fund may be used; requiring the Governor, for certain fiscal years, to include in the annual operating or capital budget bill an appropriation of at least a certain amount to the Fund: stating the intent of the General Assembly regarding a certain appropriation to the Fund in certain fiscal years; providing for the investment of money in and expenditures from the Fund; requiring interest earnings of the Fund to be credited to the Fund; exempting the Fund from a certain provision of law requiring interest earnings on State money to accrue to the General Fund of the State; authorizing certain member counties and certain other entities to submit proposals for certain grant funding; establishing the qualifications necessary to receive certain grant funding; requiring the Board to develop certain criteria to review, evaluate, and rate certain proposals for grant funding; requiring the Board to distribute certain grant funding based on certain criteria; requiring the Board to monitor and track the progress of certain projects that have received certain grant funding; authorizing the Board to reclaim certain grant funds under certain
