SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

That ~~the Laws of Maryland read as follows:~~

(a) There is a State Board of Dental Examiners Disciplinary Process and Actions Task Force.

(b) The Task Force consists of the following members:

(1) one member of the Senate of Maryland, appointed by the President of the Senate;

(2) one member of the House of Delegates, appointed by the Speaker of the House;

(3) the Attorney General, or the Attorney General's designee;

(4) two members of the State Board of Dental Examiners, designated by the Chair of the Board;

1 (5) two members of the Maryland State Dental Association, designated by
2 the President of the Association;

3 (6) one member of the Maryland Dental Hygienists' Association,
4 designated by the President of the Association;

5 (7) one member of the faculty of the University of Maryland School of
6 Dentistry, designated by the Dean of the School;

7 (8) one member who is an employee of a dental service organization,
8 designated by the President of the Association of Dental Support Organizations; and

9 (9) two consumer advocates, designated by the Office of the Attorney
10 General.

11 (c) (1) Subject to paragraph (2) of this subsection, one of the two members of
12 the Task Force designated under subsection (b)(4) of this section shall chair the Task Force.

13 (2) The chair shall be chosen by the members in attendance at the first
14 meeting of the Task Force.

15 (d) The Department of Legislative Services shall provide staff for the Task Force.

16 (e) A member of the Task Force:

17 (1) may not receive compensation as a member of the Task Force; but

18 (2) is entitled to reimbursement for expenses under the Standard State
19 Travel Regulations, as provided in the State budget.

20 (f) The Task Force shall:

21 (1) study:

22 (i) how many complaints are filed annually;

23 (ii) how a complaint is filed;

24 (iii) who is eligible to file a complaint;

25 (iv) the length of time a complaint is open;

26 (v) the time frame to provide updates and a resolution to the
27 complainant;

28 (vi) the manner in which disciplinary action from the Board is
29 publicly reported; and

1 (vii) whether a dentist should be required to carry malpractice
 2 insurance; and

3 (2) make recommendations regarding revisions to the disciplinary process
 4 and actions of the State Board of Dental Examiners that are necessary to improve the
 5 process of the disciplining dentists in the State and the disclosure of disciplinary actions.

6 (g) On or before December 1, 2021, the State Board of Dental Examiners
 7 Disciplinary Process and Actions Task Force shall report its findings and recommendations
 8 to the Governor and, in accordance with § 2-1257 of the State Government Article, the
 9 General Assembly.
