1 AN ACT concerning

2 **Education – Workforce Development Sequence Scholarships – Eligibility**

3 FOR the purpose of expanding program eligibility for Workforce Development Sequence
4 Scholarships by altering a certain definition to include certain students enrolled
5 directly in certain registered apprenticeship programs; and generally relating to
6 Workforce Development Sequence Scholarships.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Education**

20 18–3301.

1 (a) In this subtitle the following words have the meanings indicated.

2 (b) “Eligible student” means a student who[:

3 (1) Is] **IS** a Maryland resident, or has graduated from a Maryland high
4 school[;], and:

5 **[(2)] (1)** Is enrolled in a Workforce Development Sequence at a public
6 community college in the State; **OR**

7 **(2) IS ENROLLED DIRECTLY IN A REGISTERED APPRENTICESHIP**
8 **PROGRAM THAT PARTNERS WITH A PUBLIC COMMUNITY COLLEGE IN THE STATE.**

9 (c) (1) “Workforce Development Sequence” means:

10 (i) A program offered by a community college that is approved by
11 the Commission and is composed of courses that are related to:

12 1. Job preparation or an apprenticeship;

13 2. Licensure or certification; or

14 3. Job skill enhancement; or

15 (ii) A registered apprenticeship program approved by the Division of
16 Workforce Development and Adult Learning in the Maryland Department of Labor.

17 (2) “Workforce Development Sequence” does not include a sequence of
18 courses leading to an associate’s or bachelor’s degree.

19 (d) “Workforce Development Sequence Scholarship” means an award made to an
20 eligible student under this subtitle.

21 18–3302.

22 There is a Workforce Development Sequence Scholarship administered by the Office.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
24 1, 2021.
