A BILL ENTITLED

1 AN ACT concerning

2 **Public Schools – Purple Star Schools Program – Establishment**

3 FOR the purpose of establishing the Purple Star Schools Program; providing for the
4 purpose of the Program; requiring the State Department of Education to administer
5 the Program and designate a public school as a Purple Star School under certain
6 circumstances; establishing the qualifications for the designation of a Purple Star
7 School, including the provision of certain services and supports for
8 military-connected students and their families; authorizing a public school to
9 partner with a county board of education to fulfill certain requirements to qualify as
10 a Purple Star School; requiring the Department to adopt certain regulations;
11 defining certain terms; and generally relating to the Purple Star Schools Program.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Education**

20 **7–126.**

21 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
22 **INDICATED.**

23 **(2) “MILITARY–CONNECTED STUDENT” MEANS A STUDENT WHO IS A**
24 **DEPENDENT OF A CURRENT OR FORMER MEMBER OF:**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 (I) THE UNITED STATES MILITARY SERVING IN THE ARMY,
2 NAVY, AIR FORCE, MARINE CORPS, OR COAST GUARD ON ACTIVE DUTY;

3 (II) THE MARYLAND NATIONAL GUARD;

4 (III) A RESERVE FORCE OF THE UNITED STATES MILITARY; OR

5 (IV) A MEMBER OF A MILITARY OR RESERVE FORCE DESCRIBED
6 IN ITEM (I), (II), OR (III) OF THIS PARAGRAPH WHO WAS KILLED IN THE LINE OF
7 DUTY.

8 (3) "PROGRAM" MEANS THE PURPLE STAR SCHOOLS PROGRAM.

9 (B) (1) THERE IS A PURPLE STAR SCHOOLS PROGRAM.

10 (2) THE PURPOSE OF THE PROGRAM IS TO RECOGNIZE PUBLIC
11 SCHOOLS THAT PROVIDE STRONG SERVICES AND SUPPORTS FOR
12 MILITARY-CONNECTED STUDENTS AND THEIR FAMILIES.

13 (C) (1) THE DEPARTMENT SHALL ADMINISTER THE PROGRAM.

14 (2) THE DEPARTMENT SHALL DESIGNATE A PUBLIC SCHOOL AS A
15 PURPLE STAR SCHOOL IF THE SCHOOL APPLIES AND QUALIFIES FOR THE
16 DESIGNATION UNDER SUBSECTION (D) OF THIS SECTION.

17 (D) TO QUALIFY AS A PURPLE STAR SCHOOL, A PUBLIC SCHOOL SHALL:

18 (1) DESIGNATE A STAFF MEMBER AS A MILITARY LIAISON, WHOSE
19 DUTIES SHALL INCLUDE:

20 (I) IDENTIFYING MILITARY-CONNECTED STUDENTS
21 ENROLLED AT THE SCHOOL;

22 (II) SERVING AS THE POINT OF CONTACT BETWEEN THE
23 SCHOOL AND MILITARY-CONNECTED STUDENTS AND THEIR FAMILIES;

24 (III) DETERMINING APPROPRIATE SCHOOL SERVICES
25 AVAILABLE TO MILITARY-CONNECTED STUDENTS; AND

26 (IV) ASSISTING IN COORDINATING SCHOOL PROGRAMS
27 RELEVANT TO MILITARY-CONNECTED STUDENTS;

1 **(2) ESTABLISH ON THE SCHOOL’S WEBSITE AN EASILY ACCESSIBLE**
2 **WEBPAGE THAT INCLUDES RESOURCES FOR MILITARY–CONNECTED STUDENTS AND**
3 **THEIR FAMILIES, INCLUDING INFORMATION REGARDING:**

4 **(I) RELOCATION TO, ENROLLMENT AT, REGISTRATION AT, AND**
5 **TRANSFERRING RECORDS TO THE SCHOOL;**

6 **(II) ACADEMIC PLANNING, COURSE SEQUENCES, AND**
7 **ADVANCED CLASSES AVAILABLE AT THE SCHOOL; AND**

8 **(III) COUNSELING AND OTHER SUPPORT SERVICES AVAILABLE**
9 **FOR MILITARY–CONNECTED STUDENTS TRANSITIONING INTO THE SCHOOL;**

10 **(3) MAINTAIN A TRANSITION PROGRAM LED BY STUDENTS, IF**
11 **APPROPRIATE, THAT ASSISTS MILITARY–CONNECTED STUDENTS ENROLLED AT THE**
12 **SCHOOL;**

13 **(4) OFFER PROFESSIONAL DEVELOPMENT FOR STAFF MEMBERS ON**
14 **ISSUES RELATED TO MILITARY–CONNECTED STUDENTS; AND**

15 **(5) OFFER AT LEAST ONE OF THE FOLLOWING INITIATIVES:**

16 **(I) A RESOLUTION SHOWING SUPPORT FOR**
17 **MILITARY–CONNECTED STUDENTS AND THEIR FAMILIES;**

18 **(II) RECOGNITION OF THE MONTH OF THE MILITARY CHILD OR**
19 **MILITARY FAMILY MONTH WITH RELEVANT EVENTS HOSTED BY THE SCHOOL; OR**

20 **(III) A PARTNERSHIP WITH A LOCAL MILITARY INSTALLATION**
21 **THAT PROVIDES OPPORTUNITIES FOR ACTIVE DUTY MILITARY MEMBERS TO**
22 **VOLUNTEER AT THE SCHOOL, SPEAK AT A SCHOOL ASSEMBLY, OR HOST A FIELD**
23 **TRIP.**

24 **(E) A PUBLIC SCHOOL MAY PARTNER WITH THE COUNTY BOARD TO FULFILL**
25 **THE FOLLOWING REQUIREMENTS TO QUALIFY AS A PURPLE STAR SCHOOL UNDER**
26 **SUBSECTION (D) OF THIS SECTION:**

27 **(1) THE ESTABLISHMENT OF A WEBPAGE UNDER SUBSECTION (D)(2)**
28 **OF THIS SECTION;**

29 **(2) THE PROVISION OF PROFESSIONAL DEVELOPMENT UNDER**
30 **SUBSECTION (D)(4) OF THIS SECTION; OR**

1 **(3) THE DEVELOPMENT OF AN INITIATIVE REQUIRED UNDER**
2 **SUBSECTION (D)(5) OF THIS SECTION.**

3 **(F) THE DEPARTMENT SHALL ADOPT REGULATIONS TO CARRY OUT THIS**
4 **SECTION.**

5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
6 1, 2021.
