- 10 (iii) Anne Arundel County, Baltimore County, Frederick County, 11 Harford County, or Prince George's County, the notice shall be given to the county solicitor 12 or county attorney.
- 13 (4) For any other local government, the notice shall be given to the 14 corporate authorities of the defendant local government.
- 15 (d) Notwithstanding the other provisions of this section, unless the defendant can 16 affirmatively show that its defense has been prejudiced by lack of required notice, upon 17 motion and for good cause shown the court may entertain the suit even though the required 18 notice was not given.
- 19 (e) This section does not apply if, within 1 year after the injury, the defendant 20 local government has actual or constructive notice of:
- 21 (1) The claimant's injury; or
- 22 (2) The defect or circumstances giving rise to the claimant's injury.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to any cause of action arising before the effective date of this Act.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July $1,\,2021.$
