- FOR the purpose of altering the definition of a "local government" under the Local Government Tort Claims Act to include a certain nonprofit corporation in Dorchester County; providing that a certain notice requirement does not apply to certain actions

- 25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND.
- 26 That the Laws of Maryland read as follows:



## 1 Article – Courts and Judicial Proceedings

- 2 5-301.
- 3 (a) In this subtitle the following words have the meanings indicated.
- 4 (d) "Local government" means:
- 5 (28) The nonprofit corporation serving as the local public transportation 6 authority for Garrett County pursuant to a contract or memorandum of understanding with 7 Garrett County (Garrett County Community Action Committee, Inc.); [and]
- 8 (29) The nonprofit corporation serving as the industrial development 9 authority of Carroll County established under Title 12, Subtitle 1 of the Economic 10 Development Article; AND
- 11 (30) THE NONPROFIT CORPORATION SERVING AS THE ECONOMIC
  12 DEVELOPMENT AUTHORITY OF THE CITY OF CAMBRIDGE AND DORCHESTER
  13 COUNTY PURSUANT TO A CONTRACT OR MEMORANDUM OF UNDERSTANDING WITH
  14 THE CITY OF CAMBRIDGE AND DORCHESTER COUNTY (CAMBRIDGE WATERFRONT
  15 DEVELOPMENT, INC.).
- 16 5-304.
- 17 (a) This section does not apply to an action:
- 18 (1) Against a nonprofit corporation described in § 5–301(d)(23), (24), (25), 19 (26), (28), [or] (29), OR (30) of this subtitle or its employees; or
- 20 (2) Brought under § 5–117 of this title.
- 21 (b) (1) Except as provided in subsections (a) and (d) of this section, an action 22 for unliquidated damages may not be brought against a local government or its employees 23 unless the notice of the claim required by this section is given within 1 year after the injury.
- 24 (2) The notice shall be in writing and shall state the time, place, and cause 25 of the injury.
- 26 (c) (1) The notice required under this section shall be given in person or by 27 certified mail, return receipt requested, bearing a postmark from the United States Postal 28 Service, by the claimant or the representative of the claimant.
- 29 (2) Except as otherwise provided, if the defendant local government is a 30 county, the notice required under this section shall be given to the county commissioners 31 or county council of the defendant local government.

1	(3) If the defendant local government is:
2	(i) Baltimore City, the notice shall be given to the City Solicitor;
3 4	(ii) Howard County or Montgomery County, the notice shall be given to the County Executive; and
5 6 7	(iii) Anne Arundel County, Baltimore County, Frederick County, Harford County, or Prince George's County, the notice shall be given to the county solicitor or county attorney.
8 9	(4) For any other local government, the notice shall be given to the corporate authorities of the defendant local government.
10 11 12 13	(d) Notwithstanding the other provisions of this section, unless the defendant can affirmatively show that its defense has been prejudiced by lack of required notice, upon motion and for good cause shown the court may entertain the suit even though the required notice was not given.
$\frac{14}{15}$	(e) This section does not apply if, within 1 year after the injury, the defendant local government has actual or constructive notice of:
16	(1) The claimant's injury; or
17	(2) The defect or circumstances giving rise to the claimant's injury.
18 19 20	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to any cause of action arising before the effective date of this Act.
