10. Description and Purpose of Organization (Limit length to visible area)		
Howard County Government via the Howard County Department of Recreation and Parks. The Howard County Department of Recreation and Parks is responsible for the stewardship of over 9,600 acres of public lands; the maintenance and operation of more than 30 parks, 4 natural resource areas, 26 historic sites, 3 community center, a nature center, an athletic center, and various other facilities; and offering over 7,000 recreational programs. The mission of the Department is to responsibly manage natural resources; provide excellent parks, facilities, and recreation opportunities for the community; and ensure the highest quality of life for current and future generations.		

11. Description and Purpose of Project (Limit length to visible area)

Howard County is requesting a \$150,000.00 Bond Bill Grant to further the design, construction, restoration/rehabilitation, and equipping of the historic 4,226 square-foot Barnard Fort House, located within the historic district of Ellicott City and the Patapsco Valley Heritage Area. This property was acquired by Howard County in 2013 and rehabilitation of this vacant structure is necessary to enable adaptive reuse of the property. This property will support educational programing, entertainment, and tourism benefiting the local economy and post-flood recovery of Ellicott City.
