<p>Havre de Grace Little League is proud to be one of the oldest chartered Little League organizations in the world. Our league is in its 73rd year and serves approximately 400 children from the ages of 4-16 from Havre de Grace and surrounding communities. The Havre de Grace Little League was founded in 1948 by Warren C. Todd, and has served more than 20,000 boys and girls from our community with tee ball, baseball and softball programs. Today's players and volunteers represent third and fourth generation families in the program. Havre de Grace has the only Little League organization serving residents of Harford County. Our Little League program is completely volunteer-run, from the managers, coaches and umpires on the field, to the folks in the snack bar, to the league officers who oversee the day to-day functions of the organization.</p>

Stancill Park is in its 51st year serving Havre de Grace and Harford County. An improved complex at our current site provides our community with the same opportunities afforded to the youth in other areas of our county and state. An improved complex could allow our league to host tournaments, bringing visitors from out of town to benefit our tourism industry and local businesses. Harford County sees youth sports tourism as a \$50M industry. By leveraging our vision of a new youth sports destination for the citizens of Havre de Grace, alongside neighboring Ripken Baseball Youth Complex and the Great Wolf Lodge and Hollywood Casino, Harford and Cecil counties would become a youth baseball destination the benefits of that destination are open-ended for our state.
