CHAPTER _____

1 AN ACT concerning

2 **Congressional Districting Plan**

3 FOR the purpose of establishing the composition of the eight districts in the State of
4 Maryland for the election of members to the United States House of Representatives;
5 requiring that a certain question be submitted to the qualified voters of the State if
6 this Act is petitioned to referendum under Article XVI of the Maryland Constitution;
7 and generally relating to the reconfiguration of congressional districts in the State.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That Section(s) 8–702 through 8–709, respectively, of Article – Election Law of the
3 Annotated Code of Maryland be repealed.

4 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
5 as follows:

6 **Article – Election Law**

7 8–701.

8 (a) (1) The population count used after each decennial census for the purpose
9 of creating the congressional districting plan used to elect the State’s Representatives in
10 Congress:

11 (i) may not include individuals who:

12 1. were incarcerated in State or federal correctional facilities,
13 as determined by the decennial census; and

14 2. were not residents of the State before their incarceration;
15 and

16 (ii) shall count individuals incarcerated in the State or federal
17 correctional facilities, as determined by the decennial census, at their last known residence
18 before incarceration if the individuals were residents of the State.

19 (2) Beginning with the 2020 decennial census:

20 (i) on or before October 31 in the year of each decennial census, the
21 Department of Public Safety and Correctional Services shall submit to the Maryland
22 Department of Planning and the Department of Legislative Services the following
23 identifiable information, in electronic form, for each individual incarcerated in a State
24 correctional facility on April 1 in the year of the decennial census:

25 1. the name of the individual;

26 2. the address of the individual’s last known residence;

27 3. the individual’s race or ethnicity; and

28 4. any other information necessary to fulfill the purposes of
29 this section; and

30 (ii) on or before August 1 in the year of each decennial census, the
31 Maryland Department of Planning and the Department of Legislative Services shall enter

1 into a memorandum of understanding, the terms of which shall require the Department of
2 Planning and the Department of Legislative Services to work collaboratively to:

3 1. summarize the results of the geocoded data created by the
4 Department of Planning as required under COMAR 35.05.01;

5 2. using the geocoded data, identify the individuals
6 incarcerated in a State correctional facility or federal correctional facility in the State that
7 will be included in the adjusted census data under this section;

8 3. make any necessary changes to the Department of
9 Planning's geocoded database;

10 4. jointly review for accuracy any changes to the census data
11 by any software vendor or other entity; and

12 5. jointly certify, on or before March 15 in the year following
13 each decennial census, the adjusted census data to be used for redistricting under this
14 section.

15 (b) The State is divided into eight districts for the election of the State's
16 Representatives in Congress.

17 (c) (1) The descriptions of congressional districts in this subtitle include the
18 references indicated.

19 (2) (i) The references to:

20 1. election districts and wards are to the geographical
21 boundaries of the election districts and wards as they existed on April 1, [2010] **2020**; and

22 2. precincts are to the geographical boundaries of the
23 precincts as reviewed and certified by the local boards or their designees, before they were
24 reported to the U.S. Bureau of the Census as part of the [2010] **2020** census redistricting
25 data program and as those precinct lines are specifically indicated in the P.L. 94-171 data
26 or shown on the P.L. 94-171 census block maps provided by the U.S. Bureau of the Census
27 and as reviewed and corrected by the Maryland Department of Planning.

28 (ii) Where precincts are split between congressional districts, census
29 tract and block numbers, as indicated in P.L. 94-171 data or shown on the P.L. 94-171
30 census block maps provided by the U.S. Bureau of the Census and referred to in this
31 subtitle, are used to define the boundaries of congressional districts.

12 Establishes the boundaries for the State’s eight United States Congressional Districts
 13 based on recent census figures, as required by the United States Constitution.”.

14 SECTION 4. AND BE IT FURTHER ENACTED, That this Act is an emergency
 15 measure, is necessary for the immediate preservation of the public health or safety, has
 16 been passed by a yea and nay vote supported by three-fifths of all the members elected to
 17 each of the two Houses of the General Assembly, and shall take effect from the date it is
 18 enacted.
