A BILL ENTITLED

AN ACT concerning

Beverage Container Deposit Program - Establishment and Advisory Commission

FOR the purpose of requiring the Department of the Environment to establish a beverage container deposit program on or before a certain date; establishing the Advisory Commission to Develop a Beverage Container Deposit Program; providing for the composition, chair, and staffing of the Advisory Commission; prohibiting a member of the Advisory Commission from receiving certain compensation, but authorizing the reimbursement of certain expenses; requiring the Advisory Commission to develop a framework for a beverage container deposit program and make recommendations regarding the implementation of the program; requiring the Advisory Commission to report its findings and recommendations to the President of the Senate, the Speaker of the House, and certain committees of the General Assembly on or before a certain date; requiring the Department to establish, on or before a certain date, a beverage container deposit program in accordance with the Advisory Commission's framework and recommendations; providing for the termination of certain provisions of this Act; and generally relating to the establishment of a beverage container deposit program.

BY adding to

Article – Environment Section 9–1710.1 Annotated Code of Maryland (2014 Replacement Volume and 2020 Supplement)

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND. That the Laws of Maryland read as follows:

ON OR BEFORE SEPTEMBER 1, 2022, THE DEPARTMENT SHALL ESTABLISH A BEVERAGE CONTAINER DEPOSIT PROGRAM.

SECTION 2. AND BE IT FURTHER ENACTED, That:

- (a) There is an Advisory Commission to Develop a Beverage Container Deposit Program.
 - (b) The Advisory Commission consists of the following members:
- (1) one member of the Senate of Maryland, appointed by the President of the Senate;
- (2) one member of the House of Delegates, appointed by the Speaker of the House:
- (3) one representative of the Office of the Comptroller, selected by the Comptroller;
- (4) one representative of the Department of the Environment, selected by the Secretary of the Environment; and
- (5) one representative of each of the following industries and organizations, selected by the industries and organizations:
 - (i) the beverage industry;
 - (ii) the Maryland Retailers Association;
 - (iii) the National Aquarium in Baltimore;
 - (iv) Trash Free Maryland; and
 - (v) the Maryland Association of Counties.
- (c) The President of the Senate and the Speaker of the House shall designate the chair of the Advisory Commission.
- (d) The Department of the Environment shall provide staff for the Advisory Commission.
 - (e) A member of the Advisory Commission:
- (1) may not receive compensation as a member of the Advisory Commission; but

- (2) is entitled to reimbursement for expenses under the Standard State Travel Regulations, as provided in the State budget.
 - (f) The Advisory Commission shall:
- (1) develop a framework for establishing a beverage container deposit program in the State that:
- (i) reduces litter, encourages recycling, increases the quality and quantity of recycled material, and reduces greenhouse gas emissions;
- (ii) achieves a statewide beverage container redemption target of 90%;
 - (iii) provides for curbside and drop-off recycling;
- (iv) encourages public participation in the program by ensuring the convenient deposit of beverage containers;
- (v) addresses how to include all on—the—go beverage containers in the program, including aluminum, glass, and plastic containers for water, soft drinks, beer, and other alcoholic beverages; and
- (vi) establishes a minimum redemption amount of 10 cents for containers less than 24 ounces, with the potential for a higher redemption amount for larger containers; and
- (2) make recommendations regarding how to implement the program by September 1, 2022.
- (g) On or before December 31, 2021, the Advisory Commission shall report its framework and recommendations to the President of the Senate, the Speaker of the House, the Senate Finance Committee, the Senate Education, Health, and Environmental Affairs Committee, the House Economic Matters Committee, and the House Environment and Transportation Committee in accordance with § 2–1257 of the State Government Article.
- SECTION 3. AND BE IT FURTHER ENACTED, That the Department of the Environment shall establish, on or before September 1, 2022, a beverage container deposit program in accordance with the framework and recommendations made by the Advisory Commission to Develop a Beverage Container Deposit Program, as enacted under Section 2 of this Act.
- SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2021. Section 2 of this Act shall remain effective for a period of 1 year and 1 month and, at the end of June 30, 2022, Section 2 of this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
