- (i) the outcome of the assessment;
- (ii) <u>a plan to address understaffing in the State's child welfare</u> system;

(iii) estimates of the cost to address understaffing in the State's child welfare system; and

(iv) the benefits to children and families in the State of a properly staffed child welfare system.";

in line 27, strike "2." and substitute "<u>3.</u>"; and in line 28, after "2022." insert "<u>It shall</u> remain effective for a period of 5 years and, at the end of September 30, 2027, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.".
